 The lowest machinery per C2(e) above is the hot water heater. The building is in the shaded-X flood zone. The rear corner of the building plots horizontally in the AE flood zone as shown on the FIRM map. However the elevations gathered during the survey show that the building is above the AE BFE of 133.5 reported in B9 above and not in the AE zone. The rear of this lot and others next it have new concrete surface poured in the backyard. No side photos due to the design of the building. The main floor of this building at the street level door is at elevation 143.4.

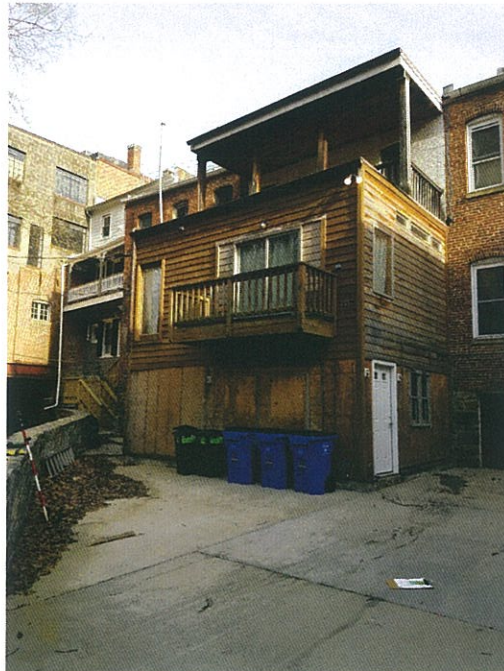
