The lowest machinery reported in C2 (e) above is the furnace at the rear of the basement floor. A portion of the building is a party wall design on both sides so photos are limited to the portion that extends out. The basement floor of the building has a small 0.8 foot jump which is reported in c2b. The main floor of the building at street level is at elevation 166.1. The BFE of the AE zone near the rear of the building is 149.5 which is reported in B.9 above. Horizontally the rear of the building plots in the AE Zone. However, the elevations gathered during the survey show the building is not in the AE Zone vertically.
