CAPSULE SUMMARY

This very well maintained two story Queen Anne dwelling is located in the old North Laurel subdivision on an approximately half acre lot. The house rests on a stone foundation and faces south on the north side of North Laurel Road three doors west of Route 1. It is flanked on the east and west by ranchers or Cape Cods that probably date to the 1940's or 1950's; one early 20th century or late 19th century house is located across the street. The frame house is covered with asbestos shingles and has an asphalt shingle roof. The original form of the building is intact with several small additions or alterations. The house retains many of its original decorative details, including a tower with a pyramid roof with flared eaves, a wrap around porch with turned supports and a sawn balustrade and frieze, and decorative verge boards.

The house at 9569 North Laurel Road is significant under Criteria C in the area of architecture. The house is a very good example of a Queen Anne style dwelling, with many original decorative details intact, sited in an early subdivision. Today, the North Laurel subdivision is made up mostly of mid to late 20th century houses but the house at 9569 North Laurel Road is an important visible reminder that the history of the subdivision goes back to the 19th century and that it is one of the earliest residential subdivisions in the county.

This very well maintained two story Queen Anne dwelling is located in the old North Laurel subdivision on an approximately half acre lot. The house rests on a stone foundation and faces south on the north side of North Laurel Road three doors west of Route 1. It is flanked on the east and west by ranchers or Cape Cods that probably date to the 1940's or 1950's; one early 20th century or late 19th century house is located across the street. The frame house is covered with asbestos shingles and has an asphalt shingle roof. The original form of the building is intact with several small additions or alterations. The house retains many of its original decorative details, including a tower with a pyramid roof with flared eaves, a wrap around porch with turned supports and a sawn balustrade and frieze, and decorative verge boards.

The house has a cross-gabled roof with a square tower in the ell between the two sections, so that the front (south) façade consists of the front gabled section, the tower, and a small portion of the side gabled section. The front façade is four bays wide with two bays in the front gabled section on the left, one bay in the tower, and one bay in the side gabled section behind the tower. The front entrance is located on the first story of the tower and features a glazed front door flanked by glazed sidelights. To the left of the door, the first story of the front gabled section is concealed behind an enclosed porch that features two small 4/4 windows on the front façade. To the right of the door, on the south façade of the side gabled section behind the tower there is another door. The four windows across the second story are all 2/2 double hung wood sash. There are paired one light casement windows in the gable of the front gabled section which is also accented by decorative verge boards and eave brackets. The tower also features another 2/2 double hung window in the third story. A finely detailed front porch spans the south façades of the front gabled section and the tower and wraps around the east façade of the tower to abut the side gabled section. The wood floored porch rests on brick piers and the hipped roof is supported by turned supports. The portion of the porch across the front gabled section has been enclosed but the rest of the porch features a sawn balustrade and frieze in a ladder-like formation.

The east façade of the tower is blank on the first and second stories but features another 2/2 window in the third story. The east façade of the side gabled section features one 2/2 window on each story, vertically aligned, and paired one light windows in the gable. A single story wing on the rear of the side gabled section has two 2/2 windows and there is another porch on the rear of this wing.

The west end of the side gabled section projects slightly beyond the west wall of the front gabled section and features one 2/2 double hung window on each story of its north and south walls in addition to the west wall. Paired one light casement windows are found in the gable. There are also vertically aligned 2/2 double hung windows on the west façade of the front gabled section, one on each story in front of the side gabled section and one on each story behind it.

The rear façade and the interior were not accessible for this survey.

This house is in excellent condition and is an important remaining example of the early development of the North Laurel subdivision. The similarity in form between this house and HO-799 and HO-847, the only other two Queen Anne dwellings in North Laurel, is striking.

The house at 9569 North Laurel Road is significant under Criteria C in the area of architecture. The house is a very good example of a Queen Anne style dwelling, with many original decorative details intact, sited in an early subdivision. Today, the North Laurel subdivision is made up mostly of mid to late 20th century houses but the house at 9569 North Laurel Road is an important visible reminder that the history of the subdivision goes back to the 19th century and that it is one of the earliest residential subdivisions in the county.

The subdivision of North Laurel was first platted in 1891 and revised in 1893. George W. Cissel, who owned the 103 acres on which the subdivision was created, entered into an agreement with a company called Gordon and Brothers to survey and subdivide his land. Gordon and Brothers did just that, producing a plat that delineated 12 different blocks each containing between 30 and 50 individual lots. According to the original plat, what is now known as North Laurel Road was originally called Gorman Avenue and the lot that the house at 9569 is located on is larger than most of the other lots in the subdivision. One of the most striking things about the plat of North Laurel is that despite the extensive number of lots created, very few seem to have been built upon in the 1890s. Only three Queen Anne houses stand today in the neighborhood which is dominated by mid 20th century domestic architecture. Deed research may illuminate who built this charming home and when they did so, but it seems very likely that the house was constructed shortly after the subdivision was created, ca. 1891.

Whoever it was built for, the house at 9569 North Laurel Road is an important intact example of a ca.1890 Queen Anne dwelling. The wrap around porch with its sawn balustrade and frieze and turned supports, the decorative verge boards in the front gable and the eave brackets, and the tower with flared eaves inset into the ell of the cross gabled form, are all representative of the Queen Anne style, and it is significant that all of these elements still exist and have not been covered or replaced with modern materials. It is also significant that the house is sited in a late 19th century subdivision. The rise of the Queen Anne style in architecture and the rise of the subdivision in community planning often went hand in hand as the two emphasized the inherent goodness in nature, home and family versus the evil influences of work and cities. Queen Anne style houses were also often built using a balloon framing technique and mass machine manufactured decorative details which allowed houses to be built quickly from stock components, and reduced the level of skill necessary on the part of the builder. The use of stock decorative components and pattern books for house plans explains why the three surviving Queen Anne houses in North Laurel all have, or probably had, identical plans and very similar decorative details. The modern subdivisions of today have their roots in the Queen Anne subdivisions of the late 19th century, and the house at 9569 North Laurel Road and the North Laurel subdivision as a whole are significant reminders of the historic nature of this 'modern' trend.




