The Choyce House (ca. 1949) is a small, intact post-WWII ranch house located southwest of the Ellicott City Historic District in a small suburban development off of Old Columbia Pike in Howard County, Maryland. The house is set on a .114-acre lot that slopes upward from the street. The house is the only building on the property.

The Choyce House is a 1-story-plus-basement, 5-bay ranch house with an L-shaped footprint and a shallow hipped roof. The house is constructed of parged CMU, retains its original wood windows and doors and painted metal gutters, and has an asphalt roof. Doors are half-glass 3 lights over 3 panels. First story windows are 2-over-2 with horizontal muntins. Basement windows are 2-light metal sash. The house is built into the sloped lot for ground-floor garage entry.

The Choyce House is significant as an intact small, mid 20th-century ranch house constructed by local builder Lawrence Choyce as his own home. The house represents trends in post World War II suburban house design, including use of modern materials and efficiency in small floor plan layout. The house is built of concrete masonry units that are coated with concrete stucco. Interior walls are finished in plasterboard. While in no way radical in exterior design, the house embraces some modernist principles including emphasis on horizontal lines, absence of exterior ornamentation, use of smooth plain surfaces, and use of metal industrial windows. Similarly, the interior is laid out for maximum efficiency in minimal square footage. Formal living room and dining room are eliminated. Instead, the house has an eat-in kitchen and a family room. Interior corridors are nearly eradicated.

The front facade of the Choyce House faces northeast. The 1st story of the house is symmetrical about its entry bay. A pair of windows, which light the living room, flank the front door. The northern window lights the kitchen and the southern window lights the front bedroom.

Although the 1st story is symmetrical, the house has an asymmetrical appearance because the house is set into the sloping lot and the garage entry is located on northern section of the basement story of the northeast facade. The garage door opening holds a recent paneled garage door. One basement window, which is vertically aligned with the southern-most 1st story window, is also located on the northeast facade.

A steep run of 14 concrete steps leads from the street-level drive to the front door. The first run of steps are edged by a concrete and brick retaining walls. The second run of steps and stoop have a simple metal rail.

The northwest (side) facade of the Choyce House has one centered 1st story window, located over the kitchen sink in the interior. There is also one basement window, which is offset to the west. The northwest (side) facade of the rear ell has one window opening, which lights the bathroom.

A covered back porch is located behind the house in the nook created by the L-shaped footprint. The porch has a concrete floor, wood posts, and a wood paneled ceiling. The porch covers the back doors leading to the kitchen, living room, and basement.

The 1st story of the southwest (rear) facade of the house has three windows and two doors. From north to south, the northern most opening is a window opening that lights the kitchen. The next opening is a door opening that leads to the kitchen. The next opening is a door opening that leads to the living room. The next opening is a window opening that lights the living room. The southern most window opening is located on the southwest facade of the rear ell - it lights the back bedroom.

The basement story of the southwest (rear) facade has one door opening and one window opening, both of which are located below grade. The basement door opening is vertically aligned with the living room window opening. The basement window opening is centered in the southwest rear ell facade.

The southeast (side) facade is symmetrical and has two window openings on both the 1st and basement stories. The 1st story openings light the two bedrooms. The basement windows are offset from the 1st story openings.

Interior

At less than 800 square feet, the interior of the Choyce House consists of family room, eat-in kitchen, and two small bedrooms and a bathroom, which open off a small back hall. The front door opens into the family room. The house retains most of its original interior features and finishes, including kitchen cabinets, wood doors, bathroom fittings, and light fixtures. Walls are plasterboard and floors are wood veneer. The back bedroom, which was the children's room, has ca. 1970 wood paneling.

Site

Although the house is located on a suburban street, the rolling topography and verdant character of the Patapsco River Valley remains present in this older neighborhood. The house is well sited to take advantage of its small, sloped lot. The lot has been terraced so that the house is set above the street level with a basement level garage. The long flights of curving stairs leading to the front door and back yard provide a transition from exterior to interior and create structure for ample perennial gardens that frame the house in the summer. Tall evergreen trees surround the house and enhance the setting.

Ownership history

The Choyce house has had only two owners. Lawrence and Helen Choyce bought the lot in the Patapsco View from Samuel J. Yates and Lucy Yates, downtown Ellicott City merchants. Lawrence Choyce was a house builder, who was the eldest son of a house carpenter, and who was raised in Woodlawn, Maryland. Lawrence built the house for his family. Helen and Lawrence brought up two sons, Richard and Gerald, on Hunter Street. Lawrence Choyce passed away and Helen Choyce sold the house to James DeArmey in 1991. DeArmey is a librarian at the main branch of the Baltimore County Public Library.






