The Daniel M. Murray, Jr. House (ca. 1924) is located on Montgomery Road adjacent to the Lawyer's Hill Historic District, Rockland (HO-151), and Belmont (HO-43). The house is set back from the road on a 23-acre lot. The aerial photograph of the property shows that there are pastures and outbuildings located behind the house and that the rear acreage of the property is wooded.

The Daniel M. Murray Jr. House, the only building visible from the public way, is a 2 <sup>1</sup>/<sub>2</sub>-story, 3bay, wood-frame, Colonial Revival style, pattern-book dwelling. The house has a side-gable roof and a rectangular footprint. The house is covered with replacement siding, has asphalt roofing, and has six-over-six windows and replacement shutters.

The Daniel M. Murray, Jr. House is associated with events that have made a significant contribution to the broad patterns of Howard County history. The property where the house is located was subdivided from the farm Rockburn (HO-151), adjacent to Belmont (HO-43). Daniel M. Murray, Jr. was a leading Howard County lawyer and legislator and was a descendent of a prominent Maryland family, who long owned and resided at Rockburn. The Howard County Historical Society holds the "Daniel M. Murray, Jr. Collection" which includes genealogical and personal biographical documents such as a photocopy from the **Maryland Historical Magazine** of a letter from Francis Scott Key regarding his friend, Daniel Murray (1778-1842). The house is representative of the evolution of substantial family estates, where later generations often constructed houses adjacent to the family seat.

The house also embodies the distinctive characteristics of its type, period, and method of construction. The house is a substantial ca. 1924 Colonial Revival style house. The Colonial Revival style was "a dominant style for domestic building throughout the country during the first of the [20<sup>th</sup>] century." The Daniel M. Murray Jr. House is amongst the most sizeable examples of the type in the county and boasts an unusually intact estate setting adjacent to two of Howard County's most significant historic properties.

The Daniel M. Murray, Jr. House (6831 Montgomery Road) was surveyed from the public way because the owners did not grant permission to survey the property. This should provide enough information for general inclusion in the Maryland Inventory of Historic Properties. However, additional documentation should be taken if the property is going to be developed or the house is going to be demolished.

The Daniel M. Murray, Jr. House (ca. 1924) is located on Montgomery Road adjacent to the Lawyer's Hill Historic District, Rockland (HO-151), and Belmont (HO-43). The house is set back from the road on a 23-acre lot. The aerial photograph of the property shows that there are pastures and outbuildings located behind the house and that the rear acreage of the property is wooded.

The Daniel M. Murray Jr. House, the only building visible from the public way, is a 2 ½-story, 3-bay, wood-frame, Colonial Revival style, pattern-book dwelling. The house has a side-gable roof and a rectangular footprint. The house is covered with replacement siding, has asphalt roofing, and has six-over-six windows and replacement shutters.

The primary façade of the house faces south. The south façade is symmetrical about its entry bay. A gable-roofed entry porch that forms a pediment with returns, which rests on Doric columns, covers the front door. Window openings flank the entry. The  $2^{nd}$  story has three window openings that are vertically with the  $1^{st}$  story openings. Two gable-roofed dormer windows pierce the front roof slope. The dormer windows are vertically aligned with the eastern and western window openings. A 2-story hipped roof projects from the east façade.

As stated in **A Field Guide to American Houses**, the identifying features of the Colonial Revival House are: "Accentuated front door, normally with decorative crown (pediment) supported by pilasters, or extended forward and supported by slender columns to form entry porch; façade normally shows symmetrically balances windows and center door; windows with double-hung sashes, usually with multi-pane glazing in one or both sashes; windows frequently in adjacent pairs." This describes the Daniel M. Murray, Jr. House to a T.

#### Owners and residents

Daniel Morris Murray, Jr. was born in Howard County, Maryland on April 16, 1907, the first son of Daniel Maynadier Murray and Amelia Norris Keys Murray. He attended Gilman Country School and graduated from Donaldson School in Howard County, Maryland with a scholarship award. He then attended Johns Hopkins University and moved on to earn a law degree from the University of Baltimore Law School. In 1933, he was admitted to the Maryland Bar. After joining the U. S. Army in 1942, Mr. Murray served in the Judge Advocate General's Office in Camp Lee, Virginia. Also during this year, he met and married Elizabeth Marshall Hunter.

On September 13, 1945, he was discharged from the Army with the rank of Staff Sergeant. At this point, he began practicing law in Ellicott City, Howard County, Maryland. During the late 1940s, Mr. Murray served two terms as the elected State's Attorney for Howard County. On October 30, 1951, he qualified as an attorney for the Maryland District Court. After being elected to the House of Delegates, he served two four-year terms in the 1950s. In 1963, Daniel M. Murray, Jr. retired from practice. He died March 26, 1988 in Westminster, Carroll County, Maryland.

In 1954, Julia Morris Bowdoin, a life-long resident of Rockburn and Daniel M. Murray's sister, died and left the property to her unmarried daughter Frances Key Murray Bowdoin, who was given the right to sell the property after offering it for purchase to her brother George E. Bowdoin. Neither Bowdoins wanted to keep the property so Frances Key Murray Bowdoin sold a small portion, where the Murray house is located, to Daniel M. Murray, Jr. and sold Rockburn to Mary Howard Bruce Smith. The Daniel M. Murray, Jr. house was likely built for Daniel M. Murray Sr. and family. In 1900, the extended Murray-Bowdoin family appear to have all lived at Rockburn. In that year, the family consisted of Daniel M. Murray (aged 40) – a lawyer, T. Morris Murray (aged 49),

brother-in-law Harry J. Bowdoin (aged 40) – a lawyer, sister Julia M. Murray (aged 35), their children Mary G. (aged 7), Frances K. (aged 4), and George (aged 2), and servants Fanny Hawkins (aged 40) – a cook, Gilberta Chabiel (aged 24) – a waitress, Fanny Halloway (aged 35) – a nurse, Annie Colter (aged 34) – a nurse, Mary Nevin (aged 30) – a chambermaid, and William Mars (aged 36) – a chauffer.<sup>2</sup> By 1910, Daniel Murray had married and he and his young family lived nearby on River Road, in Lawyer's Hill. In that year the family consisted of Murray (aged 58), wife Amelia N. (aged 36), their children Daniel M. Murray, Jr. (aged 2), and Robert T. (aged 6 months), her sister Rebecca Keys (aged 43), their African-American servants Moses Jones (aged 29) – a gardener, and Annie Jones (aged 26) – a cook, and a boarder Augusta Bathgate (aged 63).<sup>3</sup> By 1930, the family lived on Montgomery Road, adjacent to Rockburn Hill. While both sons and Rebecca Keys remained with Daniel and Amelia Murray, they no longer had live-in servants.<sup>4</sup> Daniel M. Murray, Jr. sold the house to the current owners in 1962, which was the year before his retirement.






