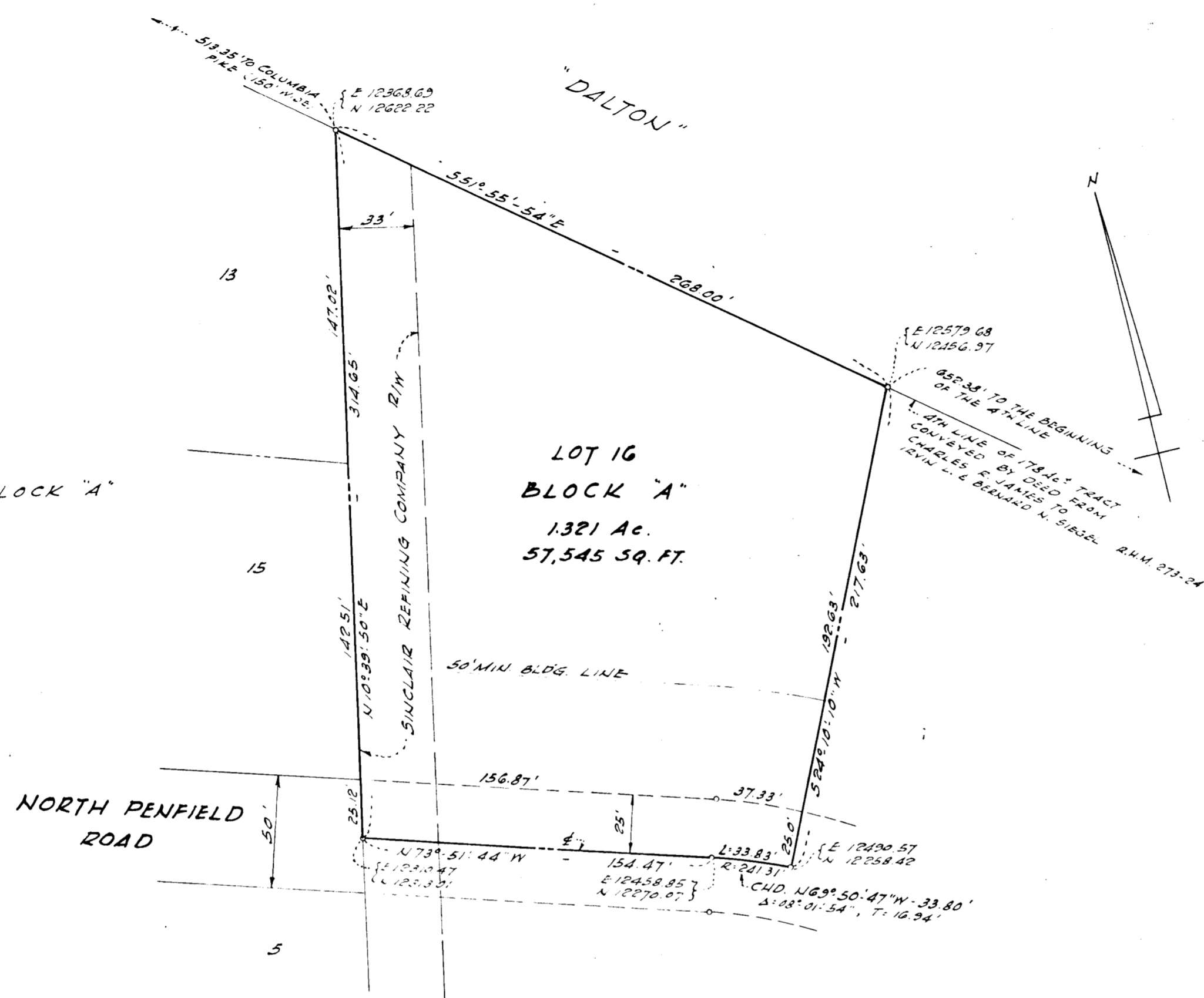


PLAT I SEC 2
