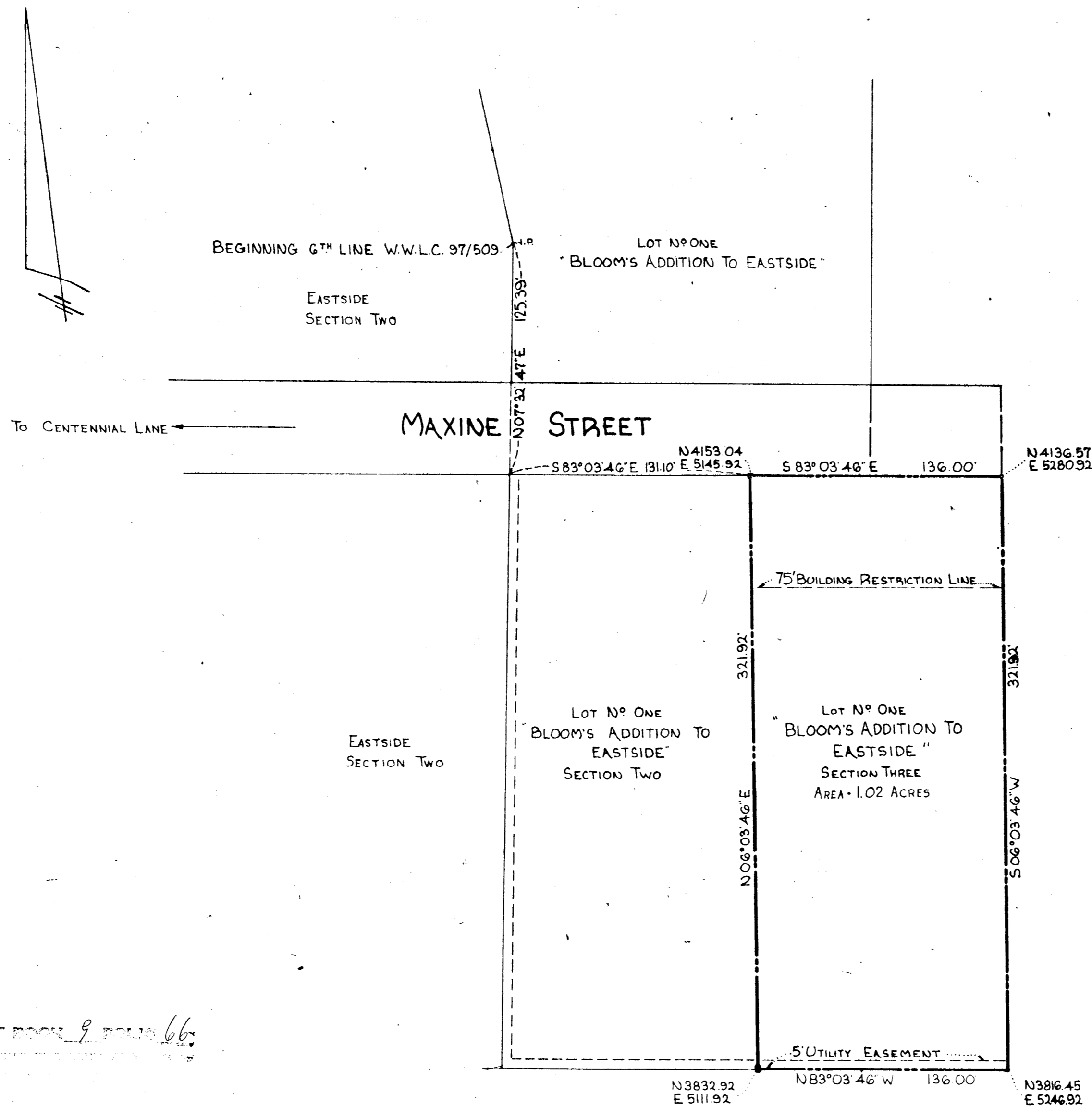


TOTAL AREA SHOWN: 1.10 ACRES ±
