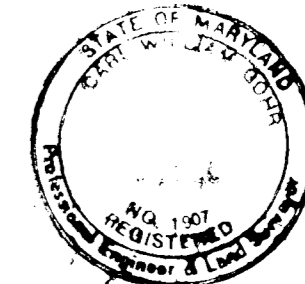
ENGINEER'S CERTIFICATE

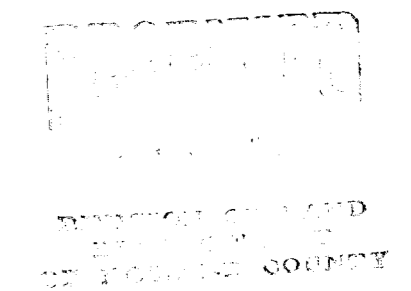
