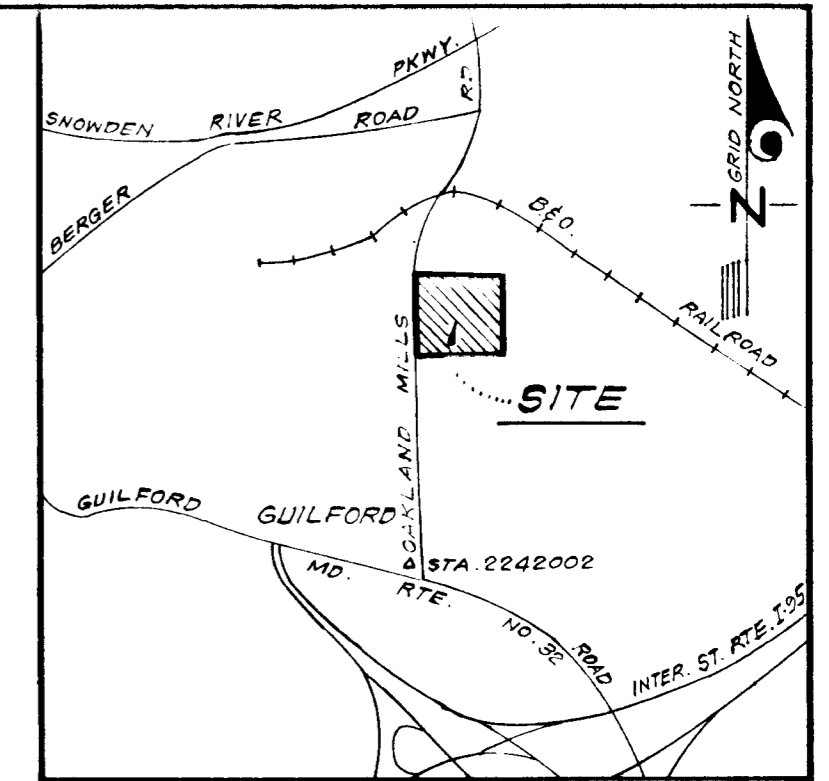
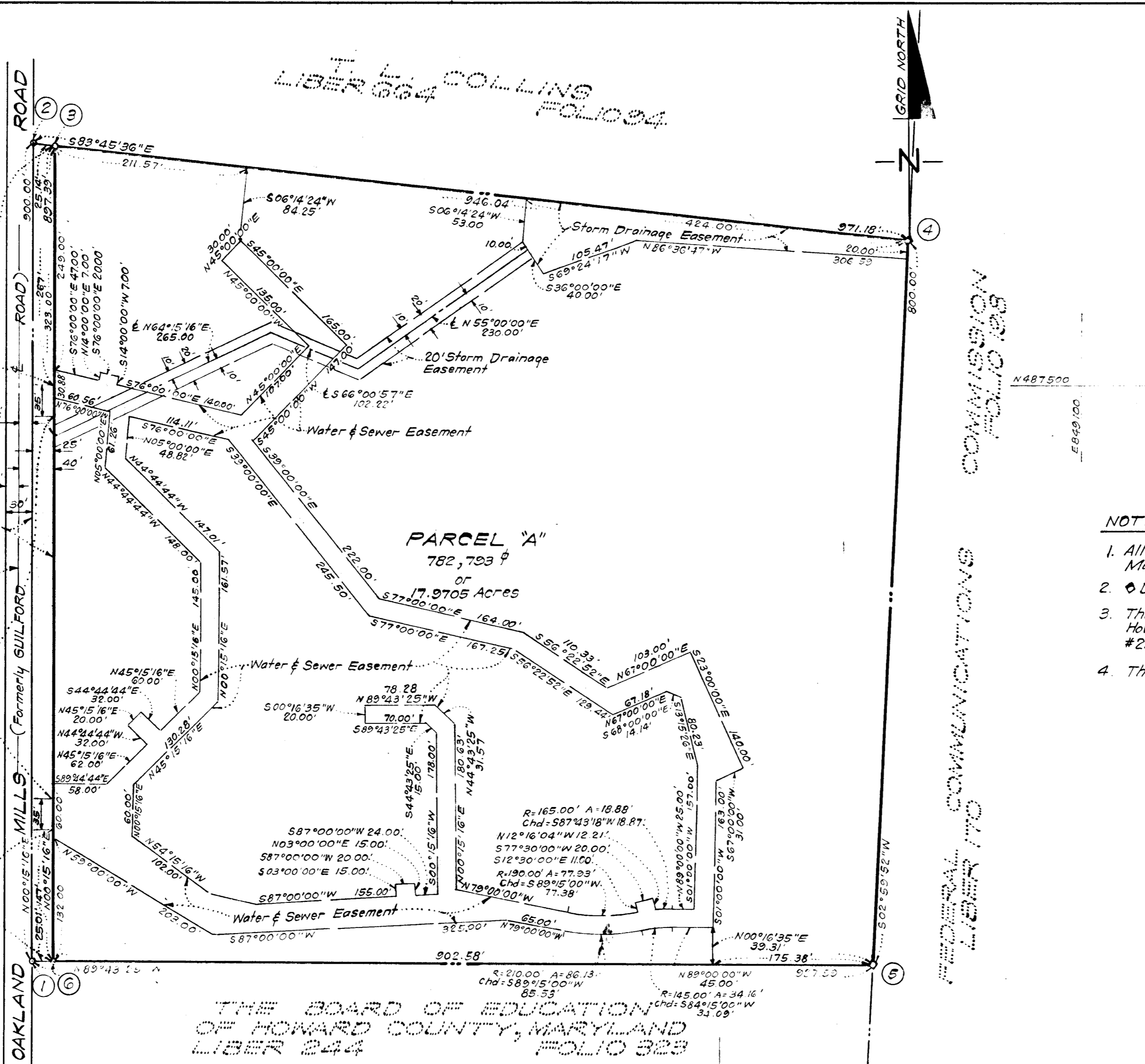

OWNERS' DEDICATION

We, Howard County, Maryland, a municipal corporation, by Edward L. Cochran, County Executive and William E. Eakle, County Administrator, owners of the property shown and described hereon, hereby adopt this plan of subdivision, and in consideration of the approval of this Final Plat by the Office of Planning and Zoning, establish the minimum building restriction lines and grant unto Howard County, Maryland, its successors and assigns, (1) the right to lay, construct and maintain sewers, drains, water pipes and other municipal utilities and services, in and under all roads and street rights-of-way and the specific easement areas shown hereon (2) dedicate to public use the beds of the streets and/or roads and flood-plains and open space where applicable, and for One Dollar (\$1.00) consideration, hereby grant the right and option to Howard County to acquire the fee simple title to the beds of the streets and/or roads and floodplains and open space where applicable; (3) that no buildings or similar structure of any kind shall be erected on or over the said easements and rights-of-way; and (4) it is further agreed that maintenance of all water-ways, drainage easements and/or floodplains, shown hereon are the responsibility of the property owner its successors and assigns.
