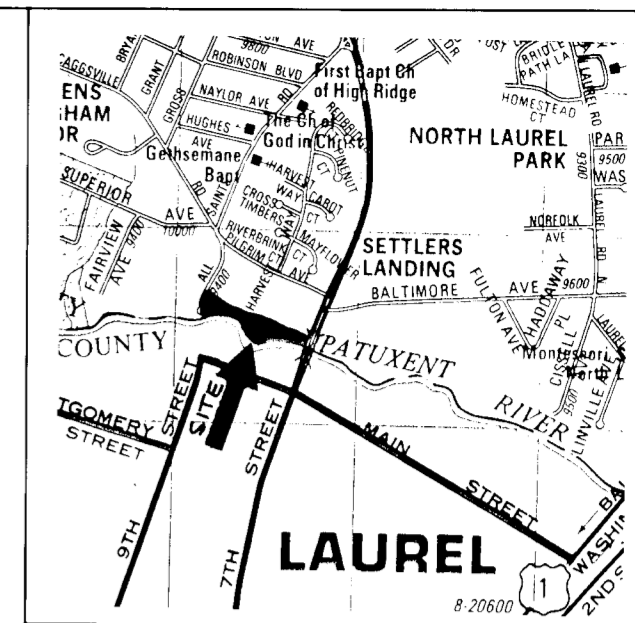
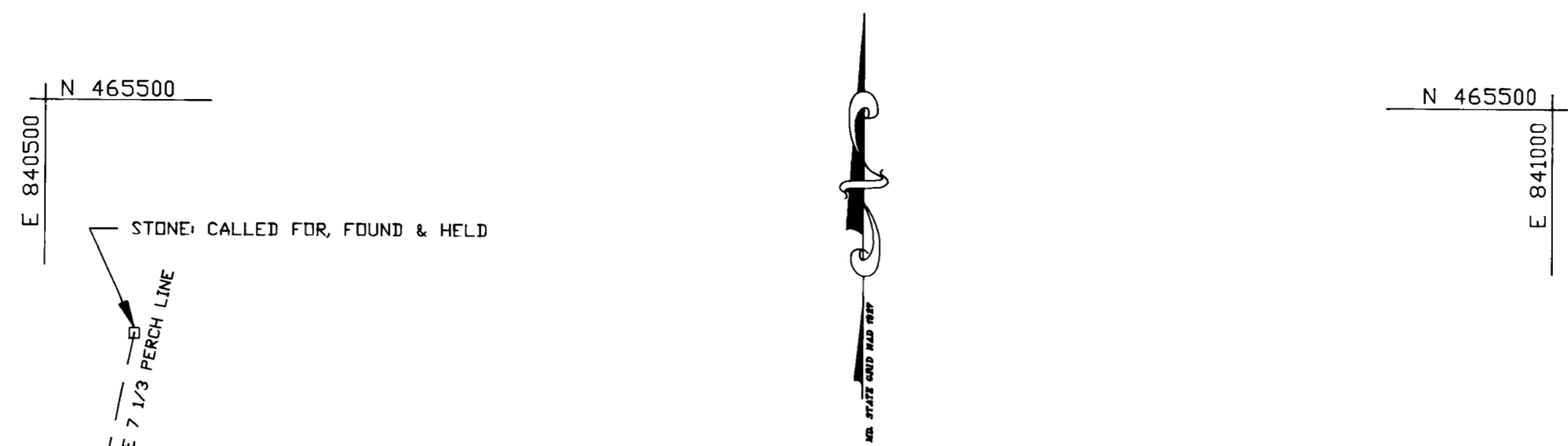

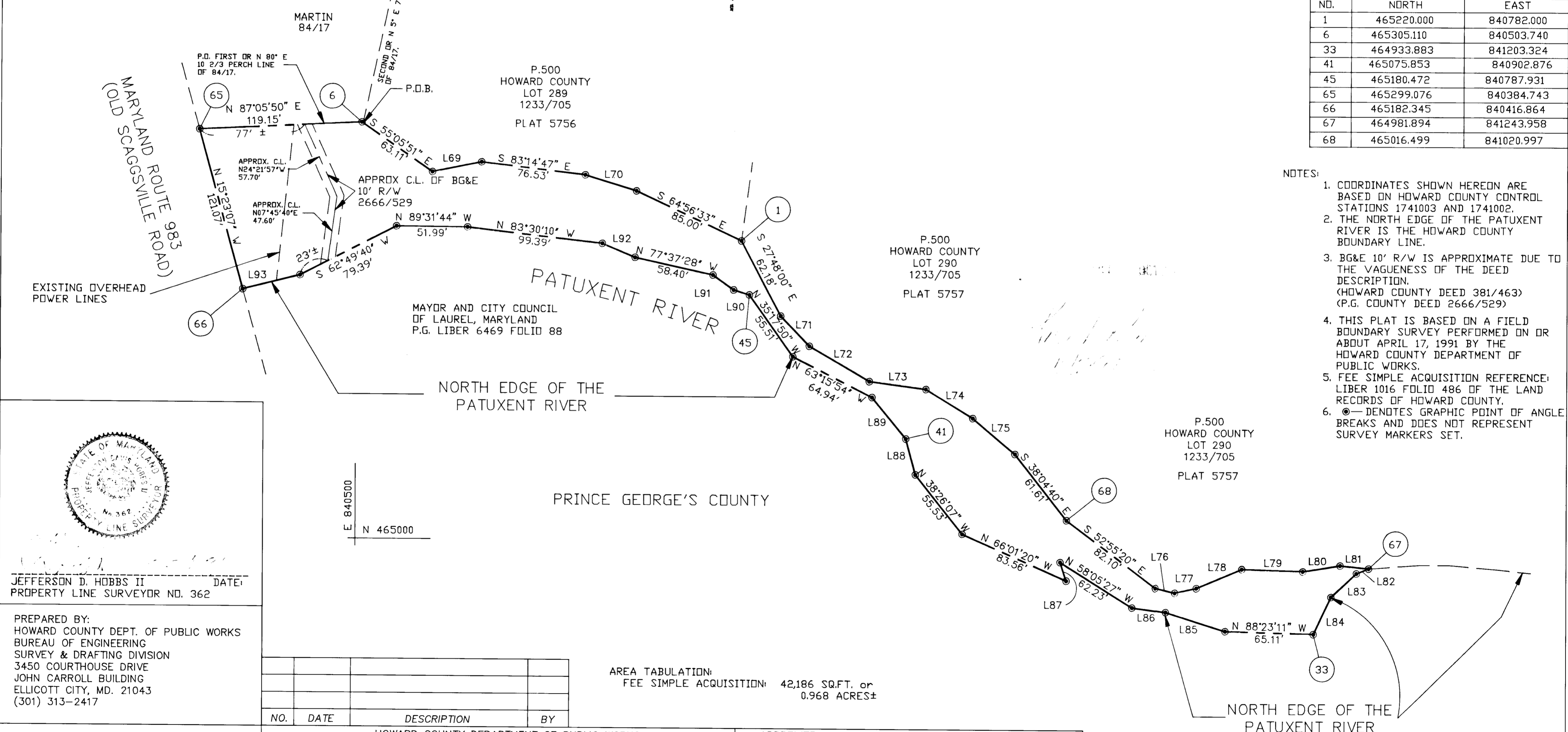
VICINITY MAP
