SODDING: 5000 ING: 1. Apply 10.10.10 fertilizer @ 1000 #/acre (25#/1000 f) 2. Apply ground agricultural limestone @ 2000 # /acre(50*/1000 f) 3. Incorporate both fertilizer & lime into soil by disoing to a min. depth of 3" firm up after incorporation. 9.4. Loy sod to a tight fit. Roll to insure contact with underlying soil. 
