This letter is to inform you that your request for alternative compliance to the Howard County Subdivision and Land Development Regulations for the subject project was reviewed.

On March 29, 2022 and pursuant to Section 16.104, the Director of the Department of Planning and Zoning, considered and **denied** your request for alternative compliance with respect to **Sections 16.116(a)(1) and 16.116(a)(2)(i)** of the Subdivision and Land Development Regulations to grade within a wetland, the wetland buffer and an intermittent stream buffer and **Section 16.1209(b)(1)** of the County Code to purchase credits from a forest mitigation bank in lieu of establishing on-site retained or planted forest conservation easements that are a minimum of 75 feet from the banks of an intermittent stream.

The Department of Planning and Zoning has acted in accordance with Section 16.104(b)(1) of the Subdivision and Land Development Regulations. The applicant was advised that additional information was required to process the alternative compliance request. The deadline to provide the additional information was March 12, 2022. Additional information was not provided to the Department of Planning and Zoning prior to the deadline. Accordingly, Section 16.104(b)(1) states:

The developer has presented a petition demonstrating the desirability of waiver; if the County requests additional justifying information, the information must be submitted within 45 days of the Department's letter of request. If the information is not submitted by the deadline, the Department <u>shall deny</u> the petition.
