Dear Mr. Mosman:

This letter is to inform you that your request for alternative compliance to the Howard County Subdivision and Land Development Regulations for the subject project was reviewed.

On November 28, 2022 and pursuant to Section 16.104, the Director of the Department of Planning and Zoning, considered and **denied** your request for alternative compliance with respect to **Section 16.155(a)(2)(ii)** of the Subdivision and Land Development Regulations to use the alternative compliance exhibit as a substitute to the site development plan process.

The Department of Planning and Zoning finds that strict enforcement of Section 16.155(a)(2)(ii) would not result in an unreasonable hardship or practical difficulty. The following factors were considered in making this determination:

1. Unreasonable hardship or practical difficulties may result from strict compliance with the regulations.

The regulations require the applicant to process a site development plan (SDP) for new residential development of single-family detached residential lots within the planned service area for both public water and sewer. The applicant has requested to process an alternative compliance application to construct a new house on an unimproved residential lot because it may take less time to process than the required SDP. The justification provided by the applicant is based on the SDP processing time, which generally does not meet the standard of practical difficulty or unreasonable hardship. DPZ staff believes a single lot SDP can be processed in a reasonable timeframe and the appropriate action is to apply the regulations to process an SDP for review as would be standard practice for other projects within the planned service area.
