

Comments The air conditioner is the lowest machinery (item c2.e above). This house has 6 different levels and is primarily diagram 3 in A.7 with a lower level of 333.4 (67% of basement floor). The lowest level is about 33% of basement floor space and is diagram 2 in A.7 at 332.4. Other levels are 335.4, 337.5, 340.1 and higher. The main level at the front door is 340.1. All of the main utilities are at 335.4 in the utility room. There is a new sump pump at 332.4.
