The lowest machinery in C2(e) above is the AC unit on the south side of the house. The furnace and hot water heater are on an upper floor at approximately 345.7. The main portion of the house has a crawl space with a sloping floor. There is one vent in the wall. It has approximately 60 square inches of opening but since it is 1.7 above the ground it is not reported in A8.b and A8.c above.
