The lowest machinery reported in C2 (e) above is the hot water heater on the lowest floor. The BFE of the AE flood zone near the house is 350.4 which is reported in B9 above, however the elevations gathered during the survey show the house is not in the AE flood zone. The lowest floor is below the BFE however being building type 4 water cannot reach that floor.
