The lowest machinery reported in C2.e above is the furnace sitting directly on the basement floor. Horizontally this house plots in the AE zone where the BFE of 232.3. However, vertically the elevations gathered during the survey show the house is on a "raised island" with all of the land close to the house 0.6' or more above the BFE. Water would be unable to get into the basement.
