Comments The furnace is the lowest machinery (item c2.e above). The AE flood zone directly behind the house has a base flood elevation of 284.0. The rear of the house plots at the edge of the AE Zone. However the elevations gathered during the survey show the house is above the BFE of the AE Zone by approximately a foot. There is a deck that is flush up against the rear wall of the house but is not bolted to the house. It is "stand alone" and the elevation at the outer post is 284.8
