The lowest machinery per C2(e) above is the hot water heater in the bathroom. The front face of the building plots very near the edge of the AE flood zone. However, the elevations gathered during the survey show all of the building is in the shaded-x zone. The BFE of the AE flood zone closest to the front corner of the building is 132.8 as reported in B9 above. The lower floor of the building has several jumps or levels. The 2nd floor of the building is approximately 147.3'.
