 C2e (lowest machinery) is hot water heater. This address is in a town house style building with 2 party walls. The 2A building best fits its design. At the lowest level there is earth behind the walls on 3 sides. The 4th side has a block party wall with another building (8141) on the other side of the wall. A rear view photo is unavailable due to design of the building. The true rear of this address falls inside the overall structure and the elevation in that area is 127.4 which is given as the LAG in C2f above. Note that the elevation of 124.8 is the closest exterior elevation to the rear of this address.
