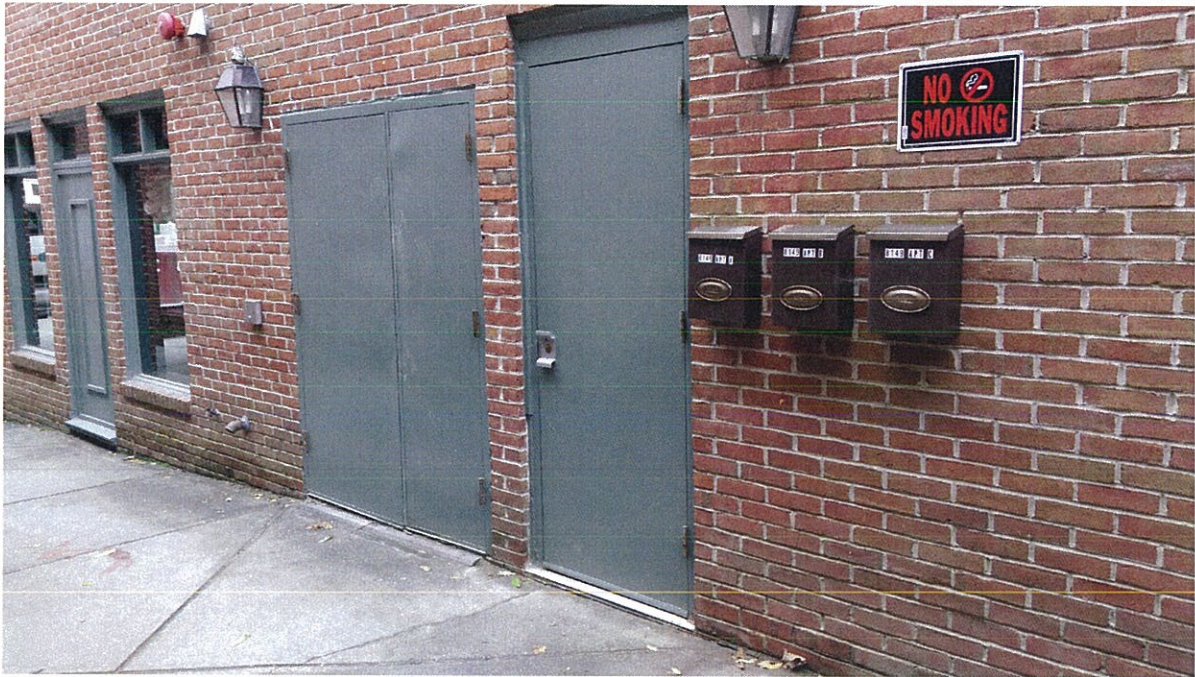

Photo One Caption Front View taken 09/27/2016

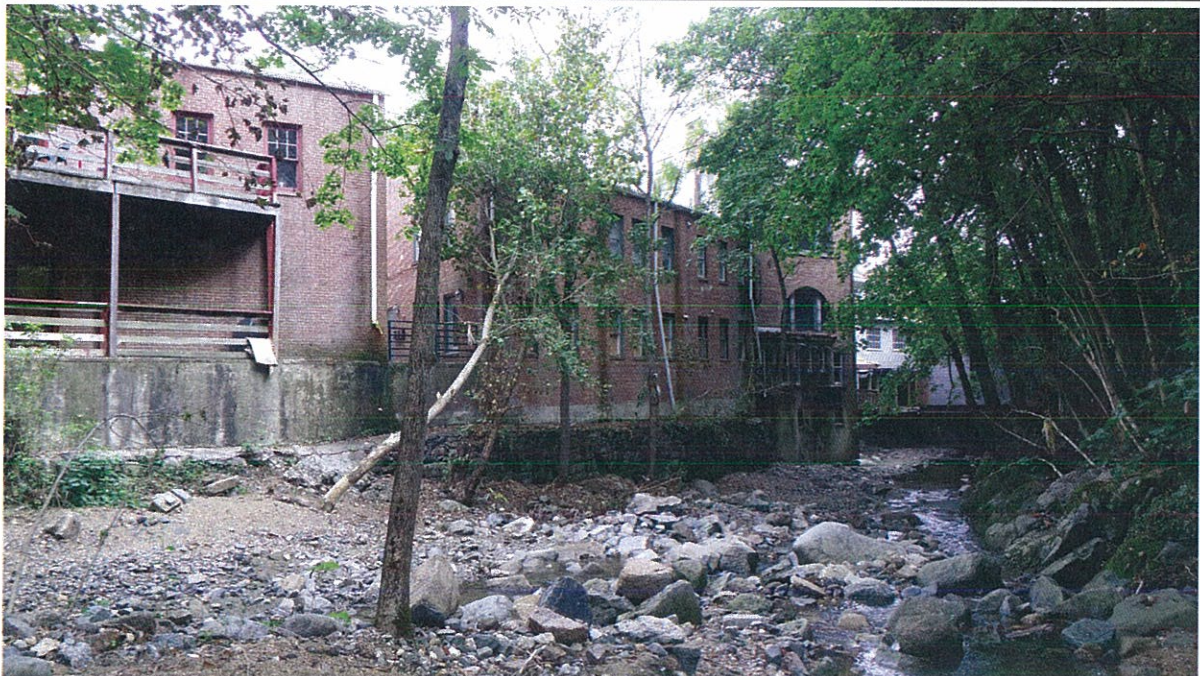
