

The rear of the building plots in flood zone AE with a BFE of 132.9 from the FIS profile for 1% chance flood which is reported in B9 above. However, the elevations gathered during the survey show the building is only in shaded zone X, not AE. The lowest machinery reported in C2(e) above is the hot water heater.
