The lowest machinery per C2(e) above is the hot water heater. The building is in the shaded-X flood zone. The BFE of the AE flood zone near the rear of the building is 133.3 as reported in B9 above. The rear of this lot and others to the west of it have new concrete surface poured in the backyard. No right side photo due to the design of the building. There are wooden steps in the rear of the building that are wedged between the buildings. They appear to be off the property and probably not attached to the building.

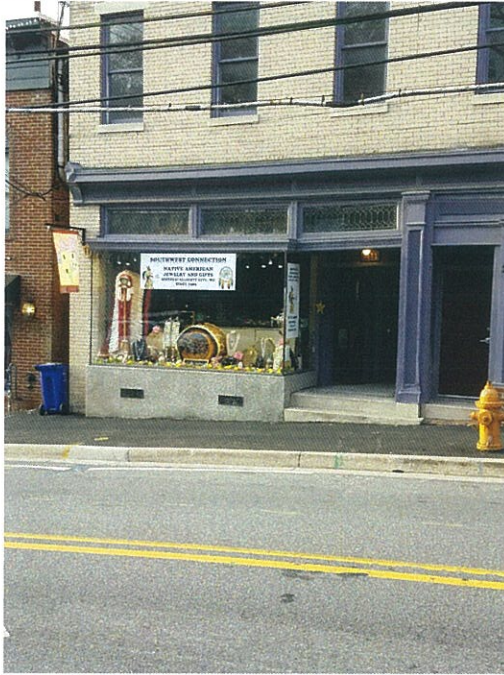

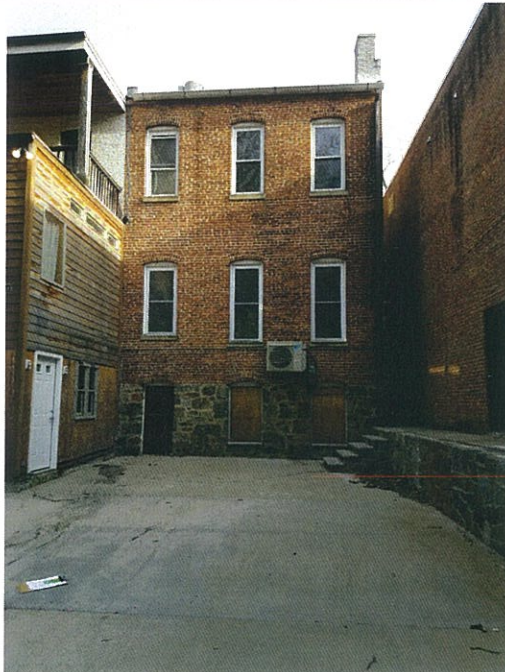

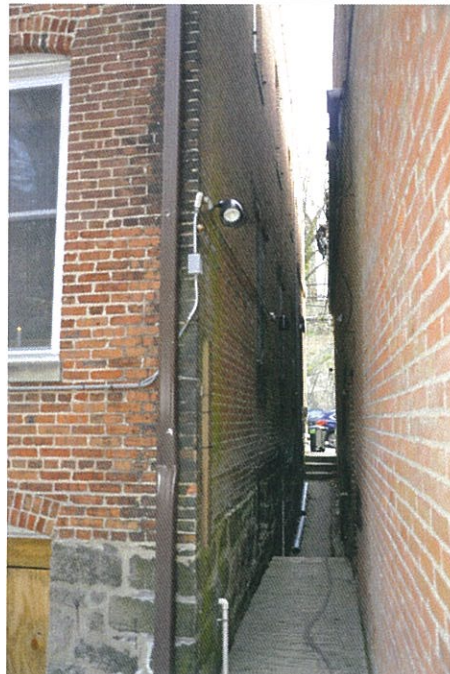
