The lowest machinery per C2(e) above is the outside air conditioner unit. The building is in the shaded-X flood zone. The building plots horizontally in the AE flood zone as shown on the FIRM map. However the elevations gathered during the survey show that the building is above the AE BFE of 135.5 reported in B9 above and not in the AE zone. The rear of this lot and others next it have new concrete surface poured in the backyard. No side photos due to the design of the building.

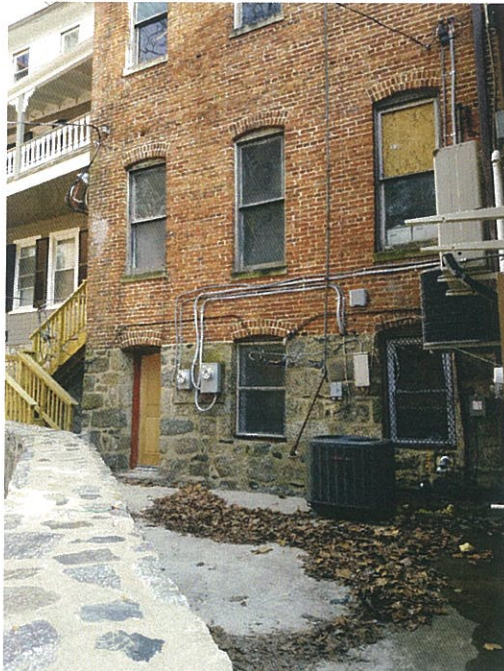
