No hot water units found @ the time of survey. 69% of the building is building diagram 6 as reported in A7. 31% of the building is building diagram 7. The rear 69% of the building is built on or supported by piers and walls. Beams support the portion of the building that is built over the stream. A party wall is under construction on the next high floor (C2b) to separate 8217 & 8225.

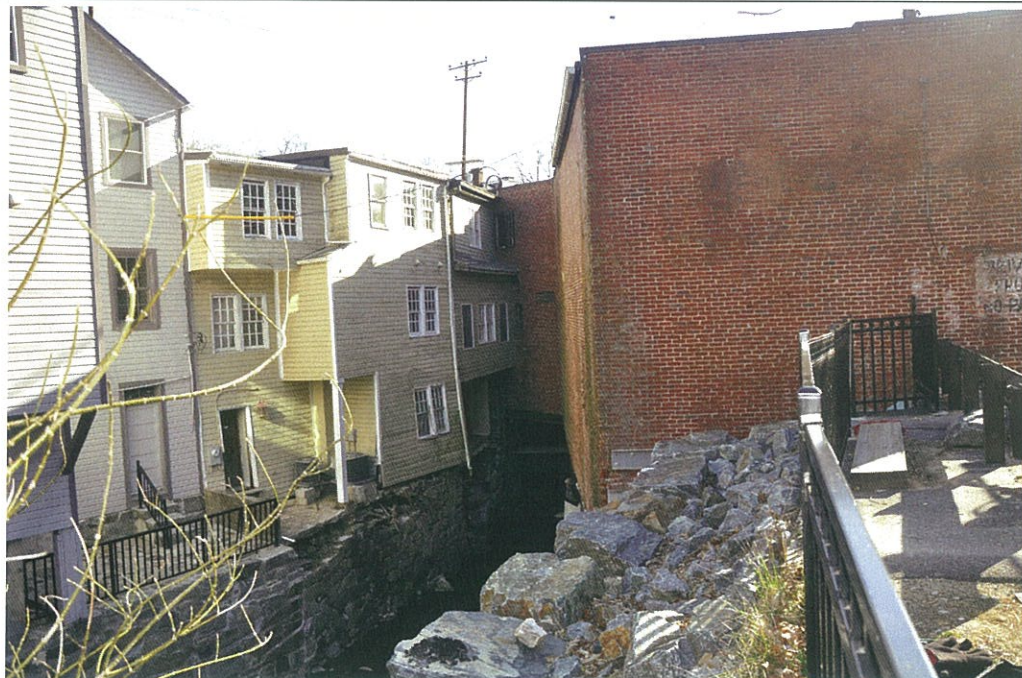
