The lowest machinery per C2(e) above is the furnace on the street level floor. The lowest level of the building is a small basement. Building diagram 7 best fits the building design since the 5 foot rule is in effect. The BFE of the AE Zone near the rear of the building is 150.0 as reported in B9 above from the FIS Profile. The design of the building does not allow for side photos.

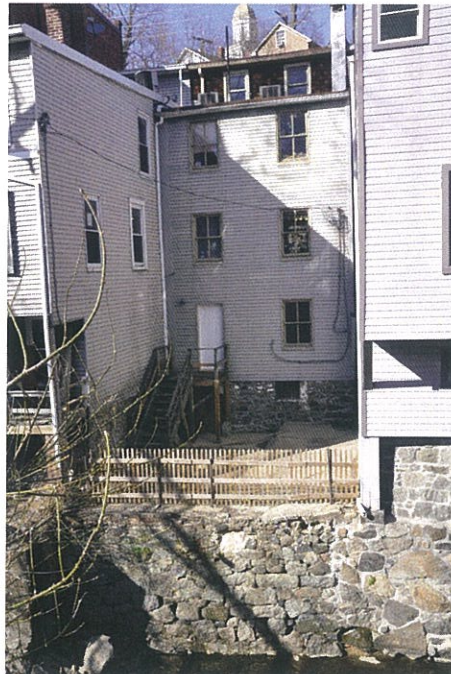
