The lowest machinery reported in C2 (e) above is the furnace on the right side of the building. The BFE of the AE flood zone near the house is 224.1 which is reported in B9 above, however the elevations gathered during the survey show the house is not in the AE flood zone. The bottom floor has a slight jump in it as reported in C2B above. The 2nd floor in the house is at elevation 239.2.
