

The lowest machinery reported in C2 (e) above is the energy exchange unit at the outside rear of the building. The lowest level of the building is a crawl space design, however the 5 foot / 2 foot rule is in effect so diagram 2A is reported in A7 above. The left side view is unavailable due to the building duplex design. The edge of this building plots horizontally in the AE flood zone. However, the elevations gathered during the survey show the building is raised up vertically about 0.8' above the AE flood zone and is in the X and X 0.2% flood zones.
