The Ellicott House faces south on the east side of Route 94, just north of its intersection with Annapolis Rock Road. It is a four bay wide, one room deep, two story high, gabled roof (running east-west) frame house resting on a stone foundation with wide brick chimneys inset into its east and west walls and a four bay wide, one room deep, two story high, intersecting gable (running north-south) log and frame north wing, incorporating a two century log house and creating an "L" plan.

A restored log cabin lies northeast of the house and a stone, gabled roof root cellar northwest, which may be the foundation for an earlier building.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ellicott House faces south on the east side of Route 94, just north of its intersection with Annapolis Rock Road. It is a four bay wide, one room deep, two story high, gabled roof (running east-west) frame house resting on a stone foundation with wide brick chimneys inset into its east and west walls and a four bay wide, one room deep, two story high, intersecting gable (running north-south) log and frame north wing incorporating a two century log house and creating an "L" plan.

The main house faces south and has a rectangular open bible and cross paneled entrance door located in the second east bay of its south wall, whose frame siding is proportionally scaled. The entrance is flanked by five vertical side lights and surmounted by a flat wooden lintel decorated with a row of dentils and surmounted by a three light transom.

The entrance is covered by a flat roofed portico, supported by two fluted columns, (originally four fluted columns) whose cornice is also decorated by a row of dentils. The roof slopes ever so slightly southward. Four second floor windows lie above, proportionally scaled and vertically aligned to the door and windows below.

The east elevation of the house holds a first and second floor, rectangular double-hung window holding six-over-six lights. Two four light attic casement windows rest above. The west elevation holds two attic four light casement windows only.

Off the east bay of the building's north wall extends the north wing. The two west bays of this wall hold two first and second floor rectangular double-hung windows with six-over-six lights. A similar hall window is located in the second east bay of this wall.

The single east bay of this section of the house is deceiving, for it is a very wide bay and holds the dining room located east of the hall, which is located in the second east bay. The hall appears, however, to be a central hall, flanked by the dining room on the east and the living room on the west. The floors of this section of the house are of heart wood Georgia pine and random width. The staircase in the hall features tapered curly maple spindles and a fine knewel post. The woodwork in the dining room and hall is composed simply of two flat pilasters and a flat lintel, with square corner decoration. This section of the house is believed to date from circa 1837.

The living room features unusually fine woodwork and crown molding. Window and door frames feature fluted pilasters and rosettes at each corner incased within a square, with paneling beneath the windows. The molding consists of a fluted wooden ceiling frame with similar rosettes at every corner of the room. An unusually fine plaster rosette is centered on the ceiling of the room.

The living room, dinning room and hall were constructed after the log house which is located in the two north bays of the north wing. Originally this log house, which features a wide stone cooking fire place on its south wall and a west entrance, now covered with a pediment, had only a loft above.

Sometime after the main house was built and this log house was used as a kitchen, the connector was constructed to join the two buildings together. This connector is two bays wide, one room deep and two stories high. To tidy up the building's roof line a full second floor and attic was then added to the original log house, whose east wall has been exposed on the interior.

The log house now has a rectangular west door, surmounted by a pediment, with a west window, holding six-over-six lights just south of the entrance. Two similar second floor windows rest above the entrance door, on either side of it. Two six light attic windows are placed above.

The north wall of the log house section holds a single first and second floor and attic window, similar to the others. Off the east wall of this log house was located a mud room which was made into a part of the log building's charming library-den. This one story high, shed roofed enclosure features a double window on its north wall and a tripartite window on its east wall, each component holding a rectangular, double-hung window with six-over-six lights. Additional six light casement windows are located on the south wall of the mud room extension, south of the tripartite window. A powder room is located in this extension. The south wall of the den's mud room section is taken up by a floor to ceiling bookcase.

The east wall of the old log building has been opened up to the mud room so that only a small section on the north and south remain. These sections however, have been completely exposed to indicate the log construction. The remainder of the log structure has been paneled and a narrow enclosed ladder staircase, similar to those used on ships, has been installed along its north wall.

The south door on the east side of the mammoth fireplace leads into the kitchen-dining nook connector. This section of the house features a first floor bay window on its west wall, covered by a semi-conical roof. The bay holds three six-over-six windows. Above rest two similar second floor windows. The east wall of this section features a four-over-four light staircase window above the kitchen entrance which opens on to a shed roofed, open porch extending along the kitchen's east wall. North of the kitchen door lies a rectangular, six-over-six light window.

From the kitchen connector to the dinning room of the main house several steps are taken. The north wall of the kitchen features an exceptionally fine perpendicular wooden mantle with keystone. All the ceiling joists in this room have been exposed.

The entire structure has been renovated and restored by Dr. and Mrs. Hugh deFries who have taken a lively interest in architectural integrity.

North east of the house stands an old log building which was recently moved to this location and totally restored by the owners. Northwest of the house is the stone foundation of what may have been another dwelling. It is now covered by a gable roof and was used as a root cellar.

STATEMENT OF SIGNIFICANCE

The Ellicott House is significant architecturally as an example of how Howard Countians added and incorporated later buildings into early log structures, as one of the few four bay wide-central hall homes and for its outstanding interior woodwork.

The one story high structure with loft faced west and later was raised to a second story when it was connected to the second structure built here; a four bay wide, two story high, gabled roof (running east-west) frame house, featuring a central hall and staircase and flat roofed portico.

The connector was two stories high and the log house was raised to meet the same height and extend the intersecting gabled roof. Because the ceilings of the log house were lower and those of the connector higher, a third floor was added to the log house.

Its architectural significance is further enhanced by it being one of the few, if only, four bay wide-central hall structures in Howard County. Houses are three bay wide or five bay wide but seldom four with a central hall.

This hall features an exceptionally fine staircase with curly maple, tapered spindles, which points to the third architectural feature of the house, its exceptionally fine woodwork. This woodwork is most unusual in the living room and dining room of the house, off the hall. That of the living room is most unusually composed of squarely cut fluted pilasters decorating doors and windows and similarly cut and fluted flat lintels. A crown molding of similar design runs around the entire living room ceiling. In addition, paneled sections lie beneath the four windows of the living room which also features an exceptionally fine mantle piece.

The wood work and crown molding in the hall and dining room are simpler in design and as well executed as that found in the living room.

An unusually fine perpendicular mantle with keystone is found in the connector-kitchen, whose rough hewn ceiling joists have been exposed to add charm as well as an architectural feature to this room.

Historically the frame main section of the building, as it now stands, dates to 1837, while the log section of the north wing could be as early as 1715. The farm was originally called "Big Meadow. It was the homestead of Basil Mullikin

Duvall who married Belilah Duvall, of Philemon, of Montjomey County. Their daughter Kate, married in 1867 George Ellicott of the family who founded Ellicott City in Howard County. They had several children, one of whom married H. Lee Hoffman of Baltimore. Their son has written articles concerning the life and times of his family and of the old house, located immediately upon the Cat tail of the Patuxent. Of historic and architectural significance, the Ellicott House should be placed on the National Register of Historic Sites.





The purpose of the flood-prone area maps is to show to administrators, planners, and engineers concerned with future land developments those areas that are subject to flooding. The U.S. Geological Survey was requested by the 89th Congress to prepare these maps as expressed in House Document 465. The flood-prone areas have been delineated by the Geological Survey on the basis of readily available information.

Flood-prone area maps were delineated for those areas that meet the following criteria: (1) Urban areas where the upstream drainage area exceeds 10 square miles, (2) rural areas in humid regions where the upstream drainage area exceeds 100 square miles, and (3) rural areas in semiarid regions where the upstream drainage area exceeds 250 square miles.

The flood-prone areas shown on this map have a 1 in 100 chance on the average of being inundated during any year. Flood areas have been delineated without consideration of present or future flood-control storage that may reduce flood levels.

Flood-hazard reports provide the detailed flood information that is needed for economic studies, for formulating zoning regulations, and for setting design criteria to minimize future flood losses. When detailed information, such as that contained in the flood-hazard reports, is required, contact the U.S. Army Corps of Engineers or the U.S. Geological Survey.
