Addendum:

This small log house is now in ruins. The roof is gone, and only two of the walls are standing (west and north). The west elevation (towards Daisy Road) had a central door flanked by two window openings, and smaller square windows above that, just below the eave line.

Ann B. Dunn's Log House faces south on the north side of Daisy Road, just west of its intersection with Jennings Chapel Road. It is a two bay wide, one room deep, two story high, gabled roof (running east-west) log house of a comfortable scale, with patches in its tin roof where once stood a brick chimney on the west wall.

The hand hewn logs are overlaid at the corners and chinked with a composition of thin stone slabs and morter.

Used two decades ago as a black tavern it is presently abandoned, settling on its north elevation and no longer features window sashes or doors.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ann Dunn Log Cabin faces south on the north side of Daisy Road, just west of its intersection with Jennings Chapel Road. It is a two bay wide, one room deep, two story high, gabled roof (running eastwest) log house with patches in its roof where once probably stood a brick chimney on the west wall.

The south elevation holds two rectangular apertures with two square second floor windows above, all of which have no sashes. A central door is located on its north wall with a window to its west, and two square second floor windows above. An additional entrance is located on its east wall with a square second floor window centered above. The west wall holds no apertures. The building is composed of hand hewn logs, separated and filled with thin stone slabs and mortar chinking. The roof appears to be of a later period than the log house with six inch boards (running east-west) covered with tin sheets of varying sizes.

The log house was at one time covered with clapboards which have been removed except in the A's formed by the gables. The house has settled considerably on its north elevation and is in a state of disrepair with no window sashes. It appears, however, quite intact and sound otherwise and should be considered for rehabilitation and future reuse with required modernization.

STATEMENT OF SIGNIFICANCE

The Ann B. Dunn Log House is significant architecturally to Howard County and the State of Marylandas a representative log house of the nineteenth century of a comfortable scale. Though settling on its north elevation and presently abandoned and in a deteriorating state, it is not beyond repair and renovation.

Thaddeus Crapster's Log House on Route 94 serves as a fine example of such renovation and use as a single family dwelling unit. The second floor of this log house is higher than that of the Thaddeus Crapster's loft and could very well provide comfortable living space of a similar nature.

Local historians point out that many of the log houses scattered throughout this district were moved from Cherry Grove, H0-1, when the slaves were freed and given their quarters after the Civil War.

Whether this log house was such or not, it stands as representative of a log house of the nineteenth century, a class of building which many Howard Countians have successfully preserved.

The Log House was used some two decades ago as a black tavern with adjacent wing. This wing which was rather unsightly, was torn down by Mrs. Dunn on the aquisition of the property. The integrity of the log house has thus been reestablished and needs only to be renovated.






