Initially Oakland Farms was a five bay wide, one room deep, two and a half story high brick structure (laid in running bond) facing east with gable roof and dormer windows, located on a tract of land known as Shipley's Discovery patented in 1726.

It is believed that Henry Forsythe built the original structure and 100 years later his grandson, Judge William Henry Forsythe, Jr. enlarged it.

This enlargement of brick, five bays wide, two bays deep and two and one half stories high was constructed along the south wall of the original structure and faces south with a central door and hall. Brick chimneys are inset into the north and south walls of the original structure and into the east and west walls of the addition.

Several one and two story porches were added to the building in the late 1890's, some of which are now enclosed or screened in.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The original structure is a five bay wide, three story high brick (laid in running bond) building with gable roof and dormer windows.

The windows are proportionally scaled from first to third stories. The first and second story windows are double-hung with six-over-six lites.

Two rectangular doors are located on the east elevation, one on the right and one on the left and surmounted by stretcher brick flat arched lintels similar to those over all the windows.

Inserted into the gable roof are two dormer roman arched windows with two-over-two lites and pointed pediment. Two brick chimneys are located on the north and south sides of the building.

The north elevation contains two four lite small windows located in the third story which rises to the apex of the roof line. The windows have header brick flat lintels.

The west elevation contains a rectangular kitchen door on the northwest corner, a rectangular pantry door south of this kitchen door, and moving south, a rectangular double-hung window with six-over-six lites on either side of a rectangular door leading on to the sun porch addition.

All doors and windows have stretcher brick flat arched lintels. It is possible that one or more of these doors were originally windows to the original house.

South Elevation: An addition was constructed against the south wall of the original structure in late 1890's. The addition is five bays wide and two bays deep facing south with a central door and hall. The south elevation has proportionally scaled fenestration. The central rectangular doorway has a five lite transom and is flanked by two double-hung windows with two-over-two lites and shutters. The second floor has five double-hung windows with two-over-two lites and shutters. Dormer windows are inserted into the gable roof, are rectangular in shape with six-over-two lites, flanked by pilasters and surmounted by a pediment. Brick chimneys are located on the east and west sides of the addition.

The west elevation has a first floor oriel window located on the right hand side supported by six brackets and capped with a hipped roof. There are double-hung windows with shutters and two-over-two lites located on the north, west and south exposures of the bay. Another double-hung window with shutters and two-over-two lites is located north of the oriel window. A cellar door is located below.

Double-hung windows with shutters and two-over-two lites are located on the second floor and two smaller windows with six lites are located within the apex of the gable roof line.

Later Additions: In the late 1890's at about the same time that Oakdale, Governor Warfield's home was being renovated, the Forsythes, friends of the Warfields, renovated their home and added several one and two story porches.

STATEMENT OF SIGNIFICANCE

Oakland Farms, circa 1843 is located on a tract of land known as Shipley's Discovery patented in 1726.

It is believed that Henry Forsythe built the original structure and 100 years later his Grandson, William Henry Forsythe, Jr., a lawyer, enlarged the house. William Henry Forsythe, Jr. served in the House of Delegates of the Maryland Assembly. In 1907 he was appointed Judge of the Fourth Judicial Circuit by Governor Edwin Warfield. Judge Forsythe was greatly respected and was reelected to a second fifteen-year term. In 1942 he became Chief Judge of the Fourth Judicial Circuit, sitting on the Court of Appeals of Maryland until retirement in 1946.

The property is presently owned by his daughter, Katharine Forsythe Barrows who unearthed an interesting stone approximately 2 feet wide, 6 feet long and ½ foot deep with the initials S.D. and the date 1726. It is believed to stand for Shipley's Discovery and the patent date of 1726.

South Elevation:

A one story flat roofed, wooden porch supported by four wooden doric columns with entablature and reached by five wooden steps and a brick bottom step was added to the south elevation. A bannister encloses the east and west sides of the porch. Stone piles form a foundation for the porch structure with wooden lattice work between the piles.

West Elevation:

A west porch added along the five bay wide original north wing of the house is supported by five wooden doric columns and entablature. Later a two story wooden sun porch filled in the south side of this open porch three bays wide. An additional one story bay of the open porch was enclosed to form a pantry and the remaining bay is screened outside the kitchen door to complete the enclosure of the original open porch.

North Elevation:

An additional one story, flat roofed wooden porch was located in the northeast corner of the addition supported by doric columns. The porch is now screened in and a rectangular door on the north elevation of the 1890 addition leads onto the screened in porch. This door is surmounted by a four lite transom.

A small frame pump house and tool shed is located on the northwest corner of the house. A barn and pond are located south of the house.




