The Warner House faces north on the south side of Route 144, attached to the east wall of H0-199, the Benjamin Barnes House. It is a two bay wide, one room deep, two story high, gabled roof (running east-west) frame structure with wide brick chimney on its west wall and appendages on its south wall.

One of the smallest houses on Route 144, it measures some thirteen feet in width and is believed to have been built by G.W. Warfield prior to 1860, according to Celia Holland, local historian.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Warner House faces north on the south side of Route 144, attached to the east wall of HO - 199 the Flohr-Barnes House.

It is a two bay wide, one room deep, two story high, gabled roof (running east-west) frame (covered with asphalt shingles) building, resting on a stone foundation, with a wide brick interior and a square brick exterior chimney rising on the south and north sides, respectively, on the east elevation, which features two small rectangular attic windows. The rectangular entrance is located in the west bay of the north wall and covered by a hipped roof, one story high porch which runs along the entire north elevation. Second floor windows are vertically aligned, proportionally scaled and double-hung, holding two-over-two lights. A two story high shed roofed appendage has been constructed along its south wall as well as a one story high kitchen porch.

STATEMENT OF SIGNIFICANCE

The Warner House is significant architecturally and historically to the town of Lisbon.

Architecturally it is important as one of the smallest houses in Lisbon, as well as playing an important role in creating the delightful streetscape on the south side of Route 144. Its connection to the west wall of H0-199, the Flohr-Barnes House and close proximity to H0-246, the Powers House, serves to make it a strong architectural element in this early nineteenth century streetscape.

According to local historian, Mrs. Celia Holland, it is believed to have been built by G.W. Warfield prior to 1860.

It has also been know as the Fowler House, former home of the village cobbler. According to Mrs. Holland, it was also used at the turn of the century by Dr. John Lacey, local physician who used one room for his medical practise.

Of human interest are the following facts related by Mrs. Holland in her article on Lisbon:

"Dr. Lacey was a member of the Howard County Medical Society which had its beginning in 1889. It was reorganized in 1904. In the minutes we find that the society held meetings on the Friday evening nearest the full moon ten months a year"

Evidently Laura J. Fowler, who acquired the property from Mary A. Knock on June 1, 1891, used the house for her and her husband Vernon's residence, as well as a place for conducting his cobbler shop and having an arrangement with Dr. Lacey.

Architecturally and historically significant to the state of Maryland, the Warner House in conjunction with the entire village of Lisbon, should be placed on the National Register of Historic Places and the State Critical Areas Program.

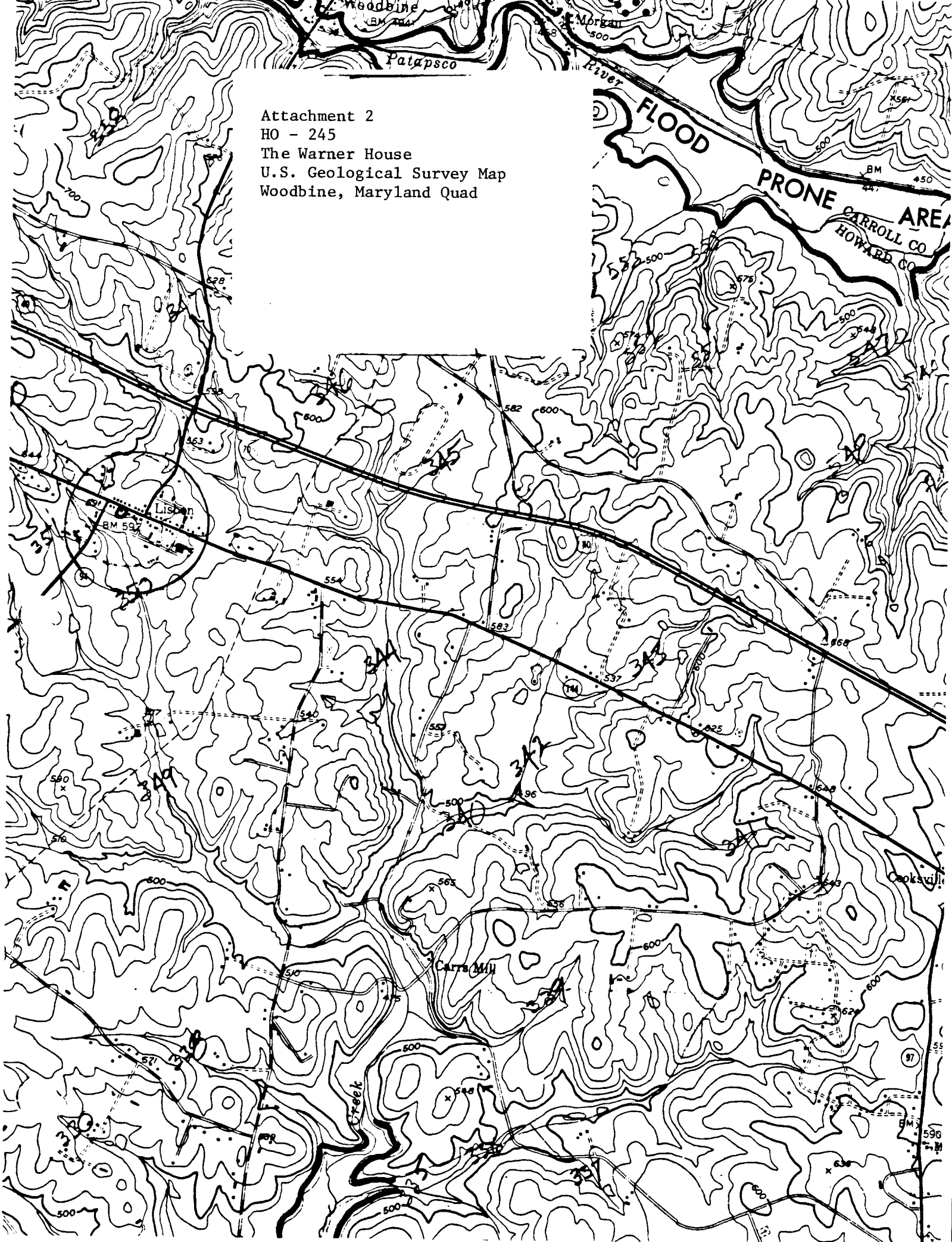
