Rose Hill faces west on the east side of Route 97, a half a mile north of its intersection with Old Frederick Road, nestling into a slight slope of ground, surrounded by mature trees and shrubs.

It is a five bay wide, two bay deep, two story high, gabled roof (runing north-south) stone house, resting on a stone foundation, with wide brick, connected twin chimneys, centered into its north and south walls. It features a one bay wide, three bay deep, one story high, gabled roof (running north-south) stone kitchen wing on its north wall, a similarly scaled, one story high, gabled roof (running north-south) screened in porch on its south wall, and a central, gabled roof portico, supported by two doric columns and two half columns on its west facade.

Fenestration for the house is proportionally scaled and vertically aligned. Windows are almost entirely double-hung, holding sixover-six lights, underlined by projecting wooden sills, decorated with wooden shutters, with almost all but the second floor, east and west windows, surmounted by flat cement lintels. These second floor windows rest just below the plain box cornice on these two elevations and are surmounted by flat wooden lintels.

The west facade holds a central, rectangular, open bible and cross paneled door, flanked by four vertical side lights and


surmounted by a seven light fan light, all of which is encased within a segmental arched, wooden archivolt.

Rose Hill is an excellent example of the Neo-Colonial Style, constructed of stone in 1921, by James and Mary Forsyth, members of the prominent Forsyth family of Howard County. It is located on a part of the following tracts of land called: "Shipley's Discovery", Robert's Advantage", "Hobson's Choice", and "Mercer's Rambles", which comprise some 208½ acres of land acquired by David H. Terhune in 1877 from Calesta and George E. Beebe, and holds an old Methodist Church, Concord Chapel. It has been a working farm for over a century and was excellently managed by Mr. James Forsyth during his tenure here.

### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Rose Hill faces west on the east side of Route 97, a half a mile north of its intersection with Old Frederick Road, nestling into a slight slope of ground, surrounded by mature trees and shrubs.

It is a five bay wide, two bay deep, two story high, gabled roof (running north-south) stone house, resting on a stone foundation, with wide brick, connected twin chimneys, centered into its north and south walls. It features a one bay wide, three bay deep, one story high, gabled roof (running north-south) stone kitchen wing on its north wall, a similar scaled, one story high, gabled roof (running north-south) screened in porch on its south wall, and a central, gabled roof portico, supported by two doric columns and two half columns on its west facade.

Fenestration for the house is proportionally scaled and vertically aligned. Windows are almost entirely double-hung, holding six-oversix lights, underlined by projecting wooden sills, decorated with wooden shutters, with almost all but the second floor, east and west windows, surmounted by flat cement lintels. These second floor windows rest just below the plain box cornice on these two elevations and are surmounted by flat wooden lintels.

### THE WEST FACADE

The west facade holds a central, rectangular, open bible and

cross paneled door, flanked by four vertical side lights and surmounted by a seven light fan light, all of which is encased within a segmental arched, wooden archivolt.

Two windows, similar to those already described, flank the central entrance, which is covered by the gabled roof portico. Five similar, second floor, vertically aligned and proportionally scaled windows rest above. The west wall of the kitchen wing holds a long, horizontal, tripartite window, each section of which is a six light casement window.

## THE SOUTH ELEVATION

The south elevation holds the gabled roof, screened in porch, which is inset on both the east and west elevations and centered on this wall. Two rectangular, twelve-twelve light, french doors enter onto this porch, which is supported by four stone piles, one at each corner. The arch motif on the west elevation is repeated in the interior roof line of the porch, which features a central barrel vault effect in the center of the ceiling, extending forward to the south wall of the eave line into a four divisional, screened in fan light, terminated and held by single doric columns.

Two second floor and one central attic window, all of which are similar to those already described, punctuate this south wall.

#### THE EAST ELEVATION

The east elevation features a centrally located cellar door, above which rests a first floor, twelve-twelve light, rectangular casement window, flanked by a similar window, above which rest three vertically aligned and proportionally scaled, rectangular, second floor, double-hung windows, holding six-over-six lights. The north end of this wall holds a small, first and second floor, rectangular, three-three light, casement window.

Three gabled roof dormer windows are inset into the roof line of this elevation. They feature closed pediments over rectangular, double-hung windows, holding six-over-six lights.

### THE NORTH ELEVATION

The second floor and attic of the north elevation is similar to the south wall. Its first floor west bay holds a rectangular, open bible and cross paneled entrance door to the office, surmounted by a flat cement lintel, while the remainder of this wall is taken up by the centrally placed, gabled roof, kitchen wing, which at one time featured an open porch, covered by the extension of its gable roof, along the east elevation. This has since been enclosed and the gable line extended for a two bay wide, one bay deep, shed roofed, frame, enclosed porch along the east elevation of the original kitchen porch. This feature enlarges the kitchen an extra bay. The north wall of the stone section holds two

rectangular, double-hung windows, holding six-over-six lights. The north wall of the two frame additions holds a similar window in the third west bay and a one-one light window inset into the wall of the enclosed porch.

## THE INTERIOR

The interior features a wide, central hall plan with innovation. Rather than one large room on either side, the plan has been arranged to incorporate only one large room off the hall on the south end of the house. The wide hall has then been shortened and the staircase put in the northwest corner, freeing the east side of the building and enabling space for a large dining room, which takes up a fourth of the floor area for the first floor. The northwest corner is then free to be used as an office or library with separate entrance. The originality and freedom of the plan is a unique feature of this house.

#### THE GARAGE - ONCE A CENTURY OLD METHODIST CHAPEL

East of the house lies a large garage, which was once used as a Methodist Chapel, and later moved to this location. It now faces north and is a one bay wide, three bay deep, one story high, gabled roof (running north-south) frame building, resting on a stone foundation, with a hipped roof apse centered on its south wall. Its west wall has been altered to accommodate a large sliding, garage door, while its gothic arched transoms on each

elevation have been blocked in and can only be seen in the interior. The building features three east rectangular, double-hung, nave, windows, holding two-over-two lights, surmounted by blocked in, three light gothic arched transoms.

The original rectangular, double, cross paneled door remains centered on the north wall and surmounted by a blocked in, three light, gothic arched transom, all of which remains on the interior. A round bull's eye is set into the "A" of the gable.

The south wall holds the chapel apse, which, in turn, holds an east and west window, similar to those already described.

The interior is noteworthy for it features all of the lathing and much of the original plaster.

#### STATEMENT OF SIGNIFICANCE

Rose Hill is an excellent example of the Neo-Colonial Style, constructed of stone in 1921, by James and Mary Forsyth, members of the prominent Forsyth family of Howard County. It is located on a part of the following tracts of land called: "Shipley's Discovery", "Robert's Advantage", "Hobson's Choice", and "Mercer's Rambles", which comprise some 208 ½ acres of land acquired by David H. Terhune in 1877 from Calesta and George E. Beebe, and holds an old Methodist Church, Concord Chapel. It has been a working farm for over a century and was excellently managed by Mr. James Forsyth during his tenure here. 4

## Explanatory Notes

1. Rose Hill is an excellent example of the Neo-Colonial Style of the early twentieth century. It features good proportions, symmetry and balance, coupled with an innovative floor plan, which blends the formality of the nineteenth century with the iconoclism of the twentieth.

This symmetry and balance is seen on the west elevation of the house. This elevation features a central entrance, covered by a one story high portico, flanking windows, proportionally scaled and vertically aligned fenestration and similarly scaled, balanced wings in the north kitchen and south screened in porch.

The innovative floor plan is reminiscent of the early German houses in western Maryland and Pennsylvania, which often feature a central hall with large, deep kitchen on one side of the hall and double pile organization on the other side. The large, deep kitchen here becomes the living room, which takes up the south side of the hall, two bays in width. It does not, however, feature an interior chimney, but one on the exterior wall of the room, another departure from the German house. The hall is shortened with a staircase to the left, a feature which is found in the Hager House in Hagerstown, Maryland. This allows for a deep, wide dining room at the end of the hall. The central bay, which holds this hall is wide, providing an open flow of space.

- 2. The builders of this fine home, James and Mary Forsyth, were members of the prominent Forsyth family of Howard County, who settled around Sykesville and Hoods Mill. They owned farms along Forsyth Road and Old Frederick Road, the most prominent being Pleasant Valley, Locust Grove and Oakland Farms, seventeenth and eighteenth century homes. His mother, Amanda Clark Forsyth, also came from a prominent family, with her brother a successful banker in Baltimore.
- 3. In 1920, Ernest I. Woolf, Elder of the Southern Methodist Church deeded Concord Chapel to James Forsyth, who later moved the Chapel to the back-yard of his residence at Rose Hill Farm for use as a garage. The farm, which his parents had deede him was once owned by David H. Terhune in 1877, who sold it to Arthur P. Forsyth of Locust Grove for \$7,050 in 1883.

4. "Rose Hill Farm", during the tenure of James Forsyth was a successful farm, operated by him, along with Locust Grove, his father's farm. Today, it remains undeveloped and it is hoped that it may continue as an agricultural operation in Howard County.




