The Zepp Farm & Outbuilding  
Clarksville  
Private

The Zepp Farmhouse faces south on the northeast corner of Routes 32 and 108. It is composed of a large barn and outbuildings and unusual square shingled farm house, which features a third floor shingled gable on each elevation, superimposed on a second floor tent roof, giving the impression of a cruciform shape. Each dormer holds a tripartite window encased in pediment styled wooden panels.

Each elevation, though equal in width and varied roof design, differs from the other.

The south facade holds a rectangular entrance in the second east bay, flanked by a rectangular, first floor, double-hung window on the east and two similar first floor windows on the west, all vertically aligned and proportionally sealed to the four similar second floor windows.

The east elevation features an interesting square, stained glass staircase window and rectangular kitchen entrance, while the west elevation holds a first floor bay window in its north bay and a covered rectangular, almost central entrance, with a double rectangular window in its south bay, which is separated and flanked by flat pilasters.

The north wall features a shed roofed, two story high, projecting bay, which holds the batten wood basement door. A hipped roof, one story high, open porch, completes the building, running around its northeast corner, with a notable sliding door on the north offering protection from the northwest winds.

Owned by the Zepp family of Howard County, it is presently owned by Mr. and Mrs. Earle Johnston, who plan to subdivide part of the existing farm.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Zepp Farm complex faces south on the northeast corner of Route #32 and #108. It is a four bay wide, two room deep, square, two story high, tent roofed structure on which a cruciform third floor, composed of a gabled roof dormer window on each elevation has been superimposed.

The dormers on each elevation, except the north, hold tripartite windows which are inset into pediment styled wooden panels. Each section of the tripartite window is rectangular and double-hung, holding one-over-one lights, with its central window taller in height.

Though totally square and featuring a roof line which is varied but identical on each elevation, the building is otherwise asymmetrical.

The south facade is very regular in treatment, holding a rectangular entrance door in the second east bay, flanked by a rectangular first floor, double-hung window on the east and two similar first floor windows on the west, all vertically aligned and proportionally sealed to the four similar second floor windows.

The east elevation features an interesting square, stained glass staircase window and rectangular kitchen entrance, while the west elevation holds a first floor bay window in its north bay and a covered rectangular, almost central entrance, with a double rectangular window in its south bay which is separated and flanked by flat pilasters.

The north wall features a shed roofed, two story high, projecting bay, which holds the batten wood basement door. A hipped roof, one story high, open porch, completes the building, running around its northeast corner, with a notable sliding door on the north offering protection from the north-west winds.

STATEMENT OF SIGNIFICANCE

This fine, well executed example of the shingle style in American Domestic Architecture of the early twentieth century is significant architecturally and histrocially.

Architecturally, it has a symmetry which forms the basic structure of this square, tent roofed structure on which is superimposed a cruciform attic roof line, created by a gabled roof dormer window being placed in the center of each elevation. Upon this very symmetrical building is placed at each elevation a variety of stylistic detail. On the south elevation we find the rectangular entrance door placed asymmetrically in the second east bay with two windows on the west and one on the east.

The west elevation, too, is asymmetrical with a central entrance placed between an oriele window in the north bay and a double window in the south bay, above which are second floor windows.

The fish-scaled shingled dormers are noteworthy, holding tripartite windows, composed of a tall central, one-over-one light double-hung window, flanked by a similar window, all of which is incased withn a pediment styled molding. This occurs on all but the north elevation.

Historically, it is associated with the Zepp family of Clarks-ville, who acquired the property from Catherine Hobbs et al. On January 2, 1900, Covington B. and Carrie Zepp conveyed the property to James Bradle Zepp (JHO 71-466). The present house was probably constructed around this time. On January 16, 1935, James B. Zepp conveyed the farm to George Watton Isenock (150-551). It is now owned by Mr. and Mrs. Earle Johnston, who are planning to subdivide a section of the farm, maintaining the house as their private residence. The alternate #6 plan for the widening and realignment of Route 108 runs just north of the Zepp Farm and outbuildings and appears to take the tree cover which would afford a natural barrier to the property. The barn and outbuildings are well p[la]ced in relation to the house, creating a corridor with path leading to the barn which acts as a focal point. This very pleasing complex could be utilized for housing when the need for agricultural use fades. It is hoped that this interesting grouping will remain and its integrity be insured by careful planning by the Highway Administration in its improvement of Route 108.

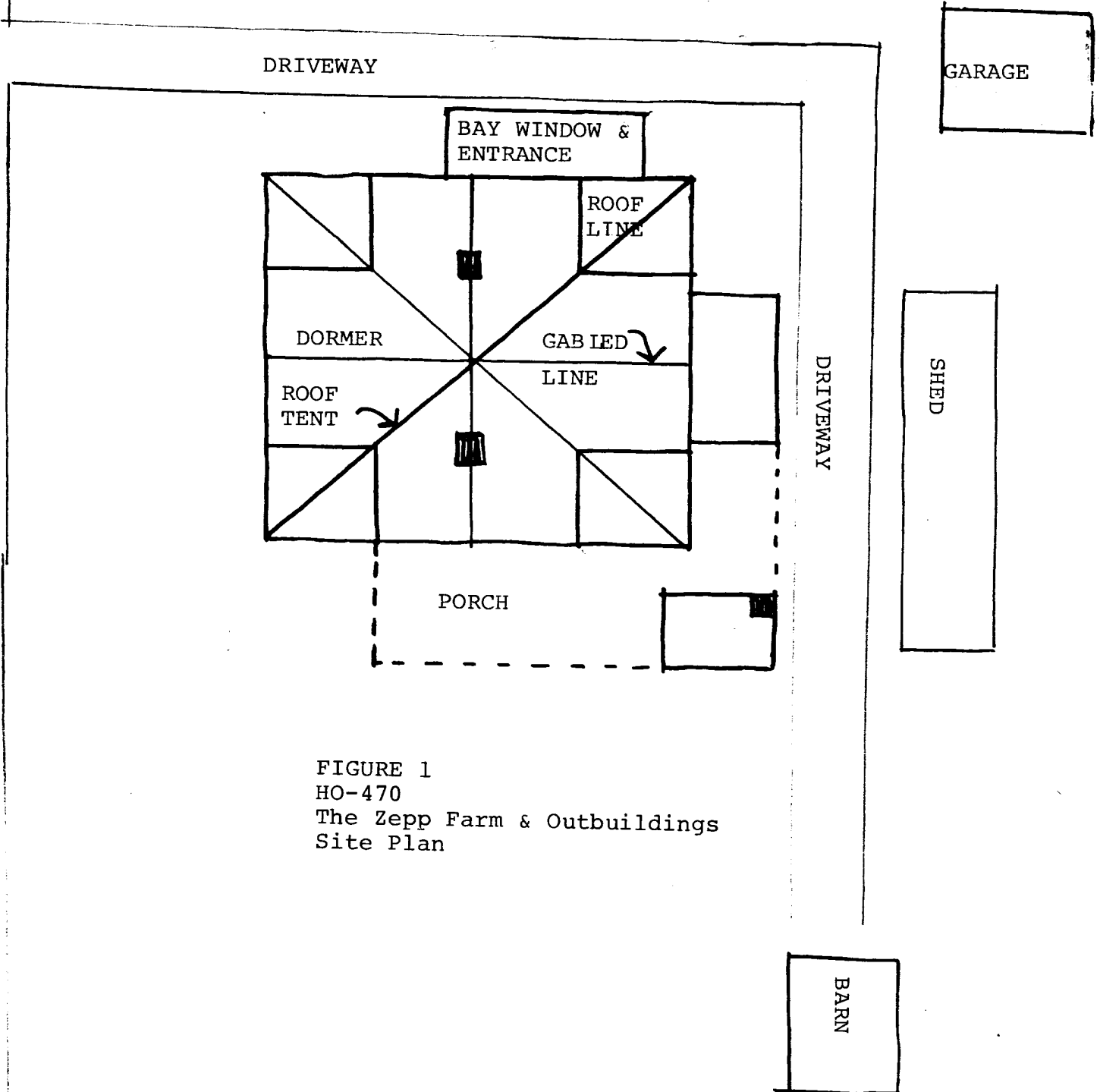

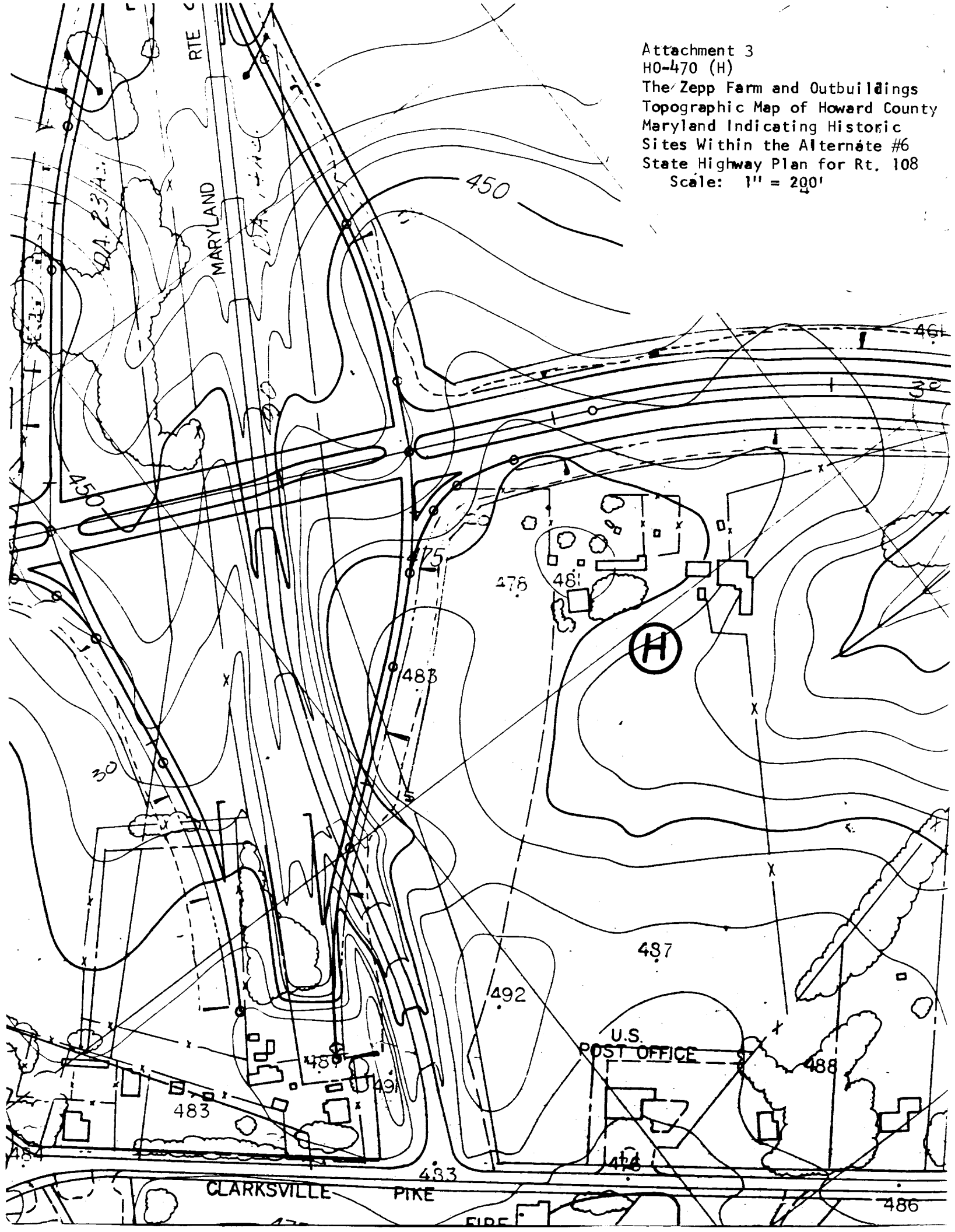
