The Martin Slagle house is located on the northwest corner of Hopkins Alley and Route 144. It is a three bay wide, three bay deep, two story high, tent roofed, square, frame building, resting on a stone foundation, with a tall square brick chimney rising from the northwest corner of the building's tent roof.

The south elevation of the house features an off-center rectangular entrance with rectangular, one-over-one light windows in the east and west bays, all of which is covered by a one story high, hipped roof open porch. Two proportionally scaled second floor windows and a jerkin roofed, central dormer window, holding two square, one light casement windows complete the facade on this elevation.

One of the last buildings constructed in circa 1918 in this early nineteenth century village of Lisbon, it is representative of the more open plan of these square, turn of the century frame buildings which dot the Howard County landscape.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Martin Slagle House is located on the Northwest corner of Hopkins Alley and Route 144. It is a three bay wide, three bay deep, two story high, tent roofed, square, frame building, resting on a stone foundation with a tall square brick chimney rising from its' northwest corner.

The south elevation of the house features an off center rectangular entrance with rectangular one-over-one light windows on the east and west, all of which is covered by a one story high, hipped roof, open porch. Five wooden steps lead to its' landing.

Two second floor windows and a jerkin roofed dormer window, holding two square, one light casement windows, complete the facade on this elevation.

The west elevation holds a central four light, rectangular entrance, covered by a gabled roof portico, supported by two wooden columns. A square one light window is located in the south bay, with a double one-over-one light rectangular window, located in the north bay.

Three one-over-one light second floor windows rest above, the middle one appearing to be a staircase window.

Along the buildings' north elevation, extends a one story high, hipped roof, semi-enclosed porch, with three second floor windows located above. Four wooden steps lead to the landing, bounded by a wooden railing on the east side, entering sliding glass doors on the west. The east elevation holds a double window, each component a rectangular one-over-one light window, in its' north bay and a one-over-one light window in its south bay. Above rest two similar second floor windows which are proportionately scaled. Beneath rest two, two-light horizontal rectangular basement windows. Two such windows are also located on the west elevation of the house.

STATEMENT OF SIGNIFICANCE

The Martin Slagle House is significant to the Town of Lisbon, Howard County and the State of Maryland architecturally and historically.

Architecturally, it is one of the last buildings constructed (circa 1918) in the town of Lisbon. It is representative of the square, two story high,hipped and tent roofed frame buildings which feature dormer windows at several elevations, constructed in the first and second decades of the twentieth century. Other examples of this house, such as the Langenfelder Farm on Route 108, exist throughout Howard County, but this remains the sole example in the Village of Lisbon, completing a compendium of Howard County architectural styles evidenced in the Town of Lisbon.

Historically it is a part of the block owned by Margaret Hekrotte in 1868, with the Old Female School, HO-230 the only building delineated upon the parcel on both the 1860 Martennet Map and the 1878 Hopkins Atlas. By 1916 this block had been acquired by Clarence Gosnell who sold the eight 1/4 acre lots to Mr. Daniel Hartsock on January 28, 1916. (100-427) A year later Martin and Annie Slagle bought this two acre property (103-276) and built the present house, which stands on the northwest corner of Hopkins Alley and Route 144, selling the adjoining Female School, HO-230, and the lot west of it, the next year to John E. Coursey for \$1,100. (105-551).

Not only is this house of significance in the development of the little town of Lisbon and its local history, but in addition, it serves as a protective anchor for the old Lisbon Female School, HO-230, which is presently unoccupied. Extremely well landscaped and maintained, it creates a strong architectural element on the northwest corner of Hopkins Alley and Route 144.

Architecturally and historically significant to the town of Lisbon, it, in conjunction with this early nineteenth century town, should be placed on the National Register of Historic Places and the National State Critical Areas Program.

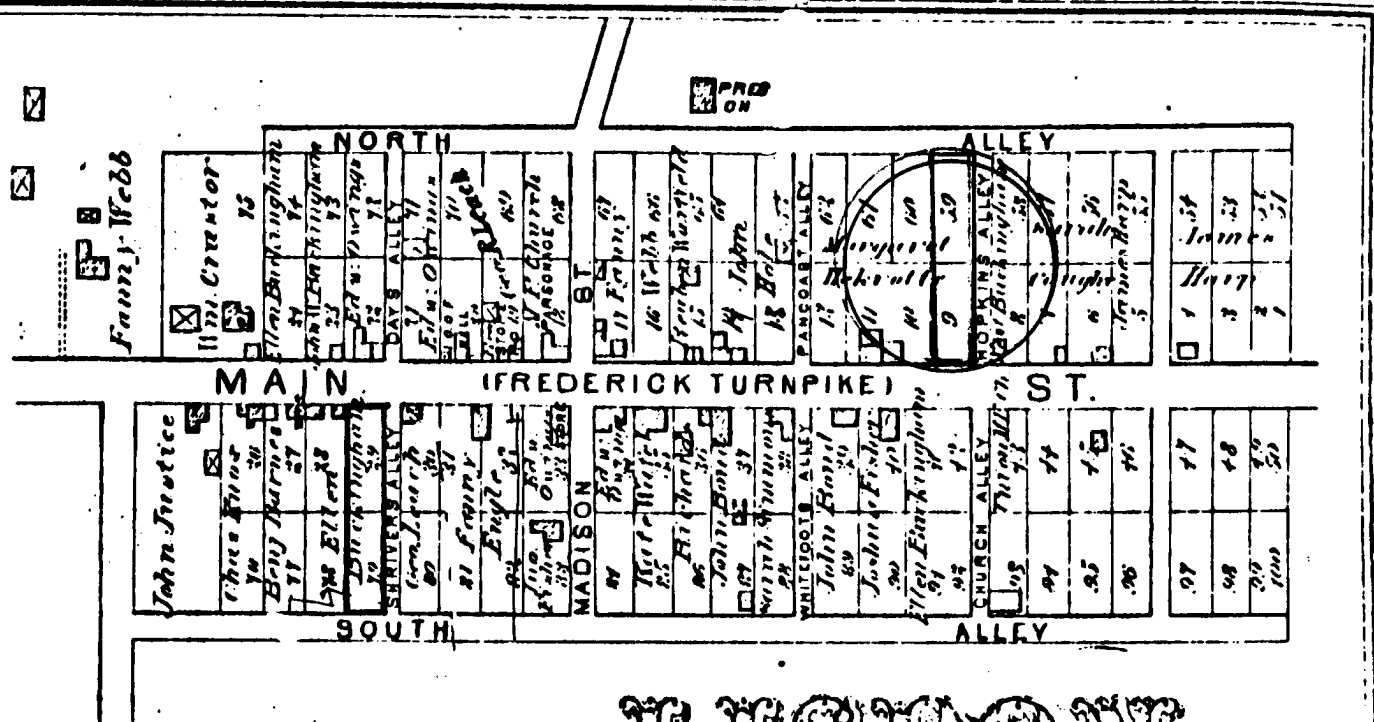

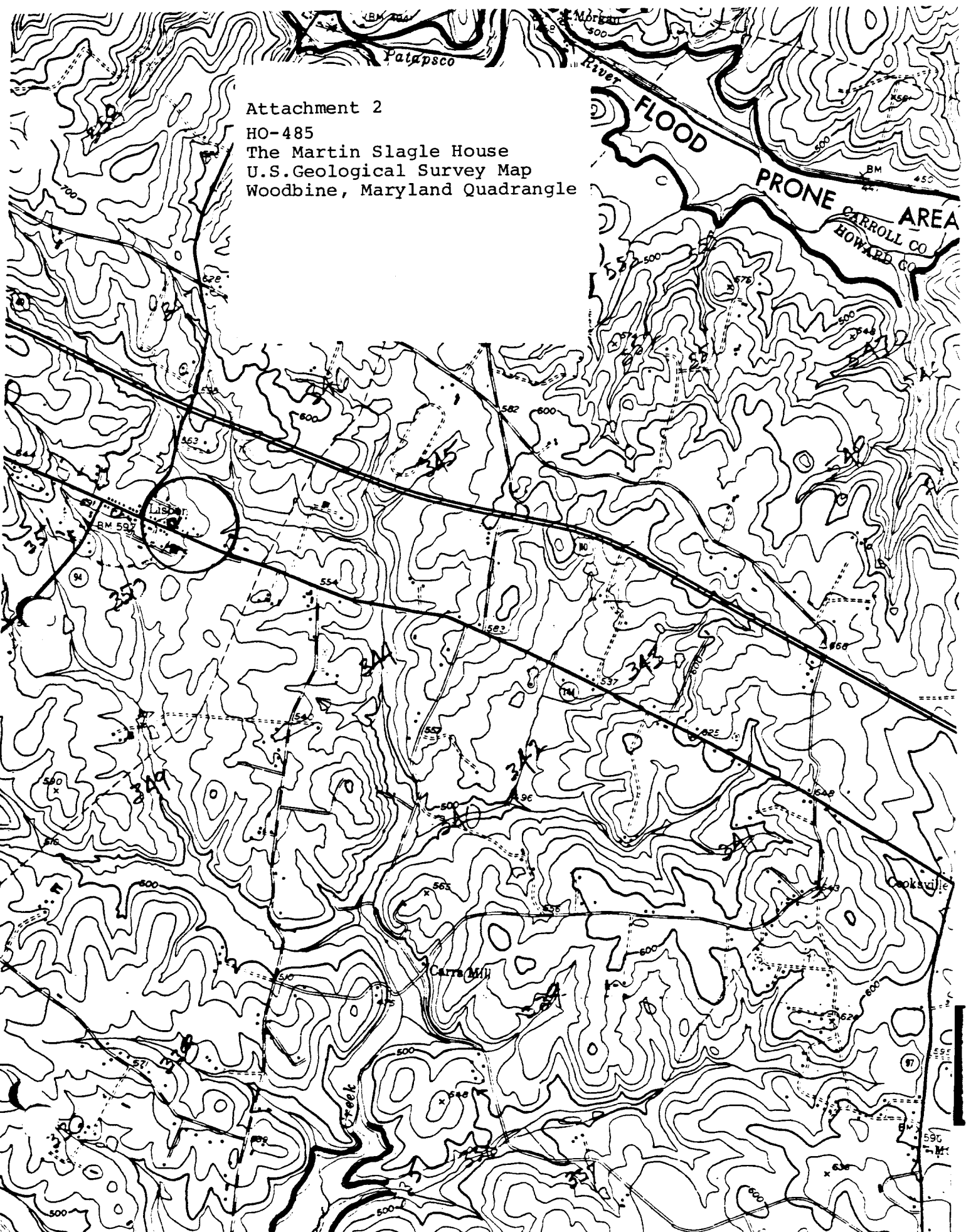
