CAPSULE SUMMARY

8474 Leishear Road (HO-690)

Erected circa 1934, the house at 8474 Leishear Road was built as a bungalow and ornamented with detailing inspired by the popular Craftsman style. This vernacular derivation incorporates features of Craftsman trends in its use of overhanging eaves, concrete block, and a full-width porch. The small scale and diluted ornamentation designate this dwelling as modest, working class housing. Since its original construction, the 1-1/2-story, three-bay house was expanded to the south by the erection of a large addition that dates from the 1970s.

The land on which 8474 Leishear Road is situated was originally part of a 110-acre tract of land. In 1933 Joseph D. Harding, owner of the 110-acre property, subdivided a portion of this land into five lots. He sold these lots, located at the northwest corner of Scaggsville Road and Leishear Road, to individual buyers. The lots were improved by the buyers with modest single family dwellings during the 1930s and 1940s. Many of the dwellings were erected as Craftsman-style bungalows. The modest size and the simplicity of these dwellings made them affordable houses that were quickly and easily erected. The unassuming dwelling at 8474 Leishear Road was one such dwelling.

The bungalow was erected sometime after 1934 when Elsie E. Waskey purchased lot 4 of the lots subdivided in 1933 by Harding. The house was retained by the Waskey family until 1955, when they sold it to the Leishear family, for whom Leishear Road is named. The Leishear family has continued to own the house at 8474 Leishear Road since that time.

The circa 1934 house at 8474 Leishear Road is a one-and-one-half-story Bungalow that has been substantially altered by the construction of a large one-story addition that extends to the south side of the house. The original wood frame dwelling is set on a parged concrete block foundation and is clad in aluminum siding. Although not high-style, the house features elements commonly associated with the then-popular Craftsman style including the roof with wide overhanging eaves and a one-story, three-bay porch that extends across the full width of the facade. The porch has Craftsman-inspired supports, brick piers with tapered posts, and a hipped roof.

At the south side of the bungalow is an overwhelming 1970s addition inspired in design by the ranch house style and clad in stretcher bond brick veneer. The one-story addition is covered with a side gable roof, and a massive exterior chimney laid in stretcher bond rises at the south elevation of the addition.

The house occupies a level lot fronting on the west side of Leishear Road. The property is open with a grassy lawn and scattered small bushes growing around the building. The property consists of approximately .614 acres. The house sits about 30 feet from the road, and a gravel driveway accesses the garage at the rear.

EXTERIOR DESCRIPTION:

The facade, the east elevation of the dwelling at 8474 Leishear Road, is composed of the original facade of the house and the one-story brick clad addition that extends to the south. The original one-story dwelling is three bays in width. The center bay is marked by a replacement single-leaf, panel-and-light door placed slightly off-center. This main entrance is flanked by replacement 1/1 metal sash windows enframed with metal casings that obscure the original window trim. The upper half story of the bungalow contains a single 1/1 metal sash in the gable end.

The southern portion of the eastern elevation is formed by the onestory side gable addition. This addition is holds a second entrance to the house, a single-leaf panel-and-light door. The door is flanked by two pairs of metal sash windows, two 9/9 to the south and two 6/6 to the north. Further north within east elevation of the addition is a metal sliding window. The north side of the building is composed solely of the original side elevation of the bungalow, which is pierced by two window openings. The windows at this elevation are replacement 1/1 metal sash windows that appear on the facade.

The west elevation of the house is composed of the original rear elevation of the bungalow, now obscured by an enclosed porch, and the aluminum clad rear wall of the 1970s addition. The enclosed hipped roof porch mimics the three-bay composition of the facade of the bungalow with a central single-leaf panel-and-light door flanked by 1/1 metal sash windows of different sizes. The upper half story is marked at this elevation by a small 1/1 metal sash window. Extending to the south of the original bungalow is the rear elevation of the addition. The west elevation contains five openings. At the north end of the addition is a double-leaf multilight metal door. At the south end, three openings are grouped together, a single-leaf, panel-and-light metal door is flanked by a small 1/1 metal sash window and a 6/6 metal sash window.

The south elevation is largely composed of the aluminum-clad south wall of the addition, which obscures most of the south wall of the bungalow. Within the exposed portion of the south wall of the bungalow, one original opening, now filled with a replacement 1/1 metal sash window, remains exposed. The end wall of the addition, devoid of openings, is dominated by the brick exterior end chimney.

OUTBUILDINGS:

Several outbuildings dot the property surrounding the dwelling at 8474 Leishear Road. These include a 1-story, concrete block garage dating from the 1970s which stands just northwest of the original dwelling. This substantial garage/storage building consists of unfinished concrete block walls capped by a side gable, asphalt shingled roof. A metal, rolling overhead door and a single, flush metal door make up the two bays of the east elevation. A single window opening containing a 1/1 metal sash window pierces the north wall of the building. The gable ends are covered with vinyl siding.

Two storage sheds occupy the southwest corner of the property. One consists of a small, pre-fabricated shed constructed of metal sheets and covered by a shallow gable roof. The adjacent shed consists of a one-story, wood frame structure clad with pre-fabricated vertical board siding and sheltered by a low-pitch front

gable roof covered in asphalt shingles. The east wall of this shed contains a single, vertical board door and a 1/1 metal sash window. Another 1/1 metal sash window pierces the north wall of the shed. Both sheds sit on a poured concrete pad that extends beyond the confines of the buildings' footprints.

The house at 8474 Leishear Road was originally part of an expansive piece of property owned by Jeremiah Hegeman until 1900. At the turn of the century, Joseph D. Harding purchased 110 acres from Hegeman, and in 1933 Harding subdivided a portion of this land into five lots. He sold these lots, located at the northwest corner of Scaggsville Road and Leishear Road, to individual buyers. The lots were improved by the buyers with modest single family dwellings during the 1930s and 1940s, many of which were erected as Craftsman-style bungalows. The modest size and the simplicity of these dwellings made them affordable houses that were easily erected and maintained. The unassuming dwelling at 8474 Leishear Road was one such dwelling. The house was erected sometime after 1934 when Elsie E. Waskey purchased lot 4 of a parcel of land subdivided by the previous owner Joseph D. Harding.

The Waskey family remained in this house until 1955, when Elsie and Melvin Waskey sold the house to the Leishear family, for whom Leishear Road is named. The Leishear family has continued to occupy this house since that time.

The house at 8474 Leishear Road presents an example of the Bungalow style as commonly constructed in rural areas during the 1920s through the 1950s. Despite the addition to the south, the original structure retains its compact, economical form, hipped-roof, fullwidth front porch, and wide eaves, all derived from the Craftsman style.




