Justification for decision: (Use continuation sheet if necessary and attach map)

The abandoned house at 11125 Scaggsville Road is not eligible due to the fact that it does not meet National Register Criteria A, B, C, or D. Preliminary research has not revealed any association between the dwelling and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in our past (Criterion B). Although the building provides an example of the Craftsman-style Bungalow, it is neither unusual nor distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). There is no evidence that the property is likely to yield information important in history or prehistory (Criterion D). Thus, the property is not National Register-eligible.

**CAPSULE SUMMARY**  
11125 Scaggsville Road  
(HO-717)

The circa 1925 Craftsman-style Bungalow at 11125 Scaggsville Road is a one-and-one-half-story, side gable building with two gable dormers at the southwest elevation and an enclosed porch. The wood frame house sits on a solid, rock-faced concrete block foundation, and the wood frame walls have been reclad with asbestos shingles. The roof is covered in asphalt shingles, and a raking cornice with a wood fascia board follows the line of the eaves. Exposed rafter tails are visible. There is one interior brick chimney laid in stretcher bond. The one-story, shed roof, wood frame porch that spans the full width of the house on the southwest elevation has been enclosed.

The property on which 11125 Scaggsville Road stand is comprised of three distinct parcels of land, owned until the 1960s and 1970s by separate individuals. Parcel A, consisting of approximately 40 acres, was purchased by the Cherrytree Farm, Inc. in 1968. The corporation acquired the two adjacent parcels in 1969 and 1973. Renamed the Cherrytree Corporation, the company owns over 42 acres.

The circa 1925 Craftsman-style Bungalow at 11125 Scaggsville Road is a one-and-one-half-story, side gable building with two gable dormers at the southwest elevation and an enclosed porch. The wood frame house sits on a solid, rock-faced concrete block foundation, and the wood frame walls have been reclad with asbestos shingles. The roof is covered in asphalt shingles, and a raking cornice with a wood fascia board follows the line of the eaves. Exposed rafter tails are visible. There is one interior brick chimney laid in stretcher bond. The one-story, shed roof, wood frame porch that spans the full width of the house on the southwest elevation has been enclosed.

The dwelling is located fifteen feet northeast of Scaggsville Road. The house is abandoned and in a dilapidated state. The property is densely overgrown. The site is enclosed with a chain-link fence to the southeast of the house, and an over grown driveway passes the house on the northwest.

**EXTERIOR DESCRIPTION:**

The first story of the southwest, or main facade, was not easily visible due to overgrown vegetation. Each of the two dormers within the upper half-story is pierced by a window opening with wood sills; the sashes, however, are missing.

The northwest elevation is marked at the first story by two 3/1 windows and one 1/1 window. The upper half-story is pierced by one 3/1 and one 1/1 window. All of the window openings have wood sills. A door at one time pierced this elevation at the first story.

The northeast elevation is pierced at the first story by four 3/1 windows and two 6/1 windows. A single-leaf, panel-and-light door with square-edged trim also marks the first story.

The southeast elevation holds two 3/1 windows and one 1/1 window within the first story. The upper half-story is pierced by one 3/1 and one 1/1 window.

Erected circa 1925, the house at 11125 Scaggsville Road is an illustration of the modest Craftsman-style Bungalow popular in rural areas in the second quarter of the 20th century. This housing type was popular among middle-class homeowners because it was inexpensive to build and easy to maintain.

Despite its dilapidated state, the house at 11125 Scaggsville Road is characteristic of much of the modest, residential architecture constructed in Scaggsville during the first half of the twentieth century.

The property on which 11125 Scaggsville Road stand is comprised of three distinct parcels of land, owned until the 1960s and 1970s by separate individuals. Parcel A, consisting of approximately 40 acres, was purchased by the Cherrytree Farm, Inc. in 1968. The corporation acquired the two adjacent parcels in 1969 and 1973. Renamed the Cherrytree Corporation, the company owns over 42 acres.

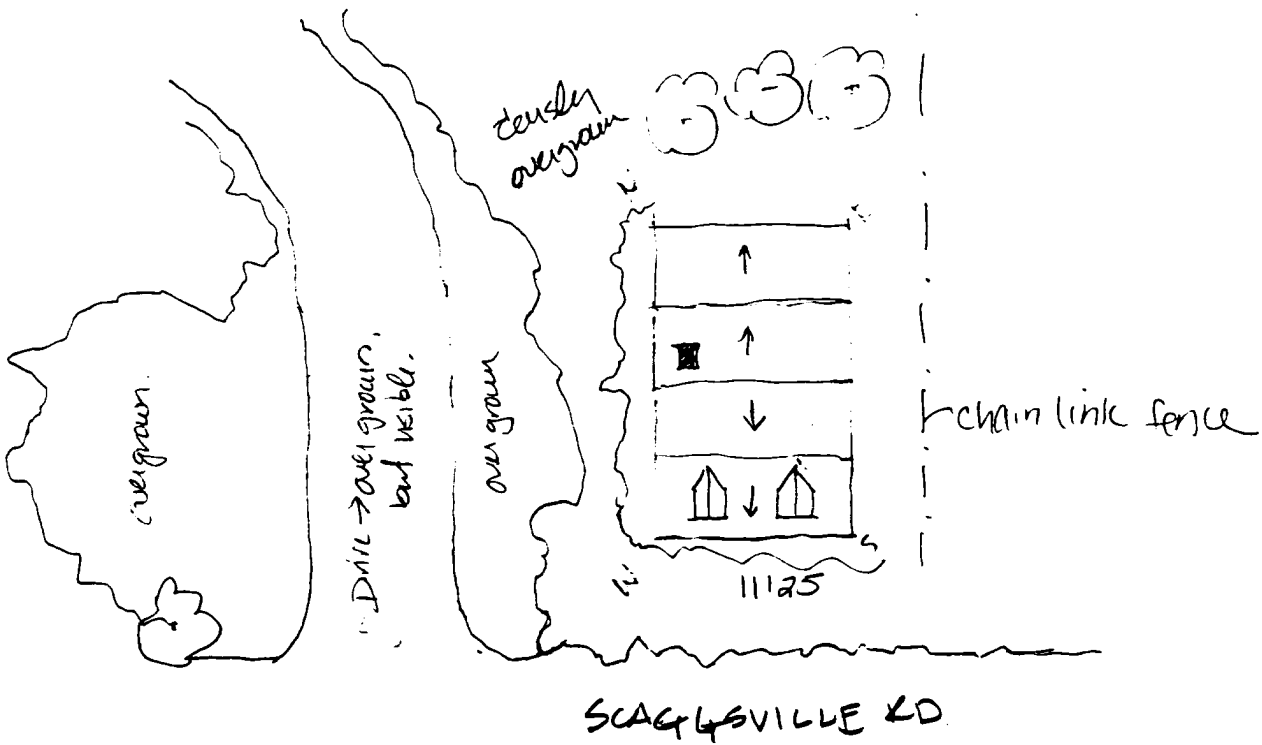

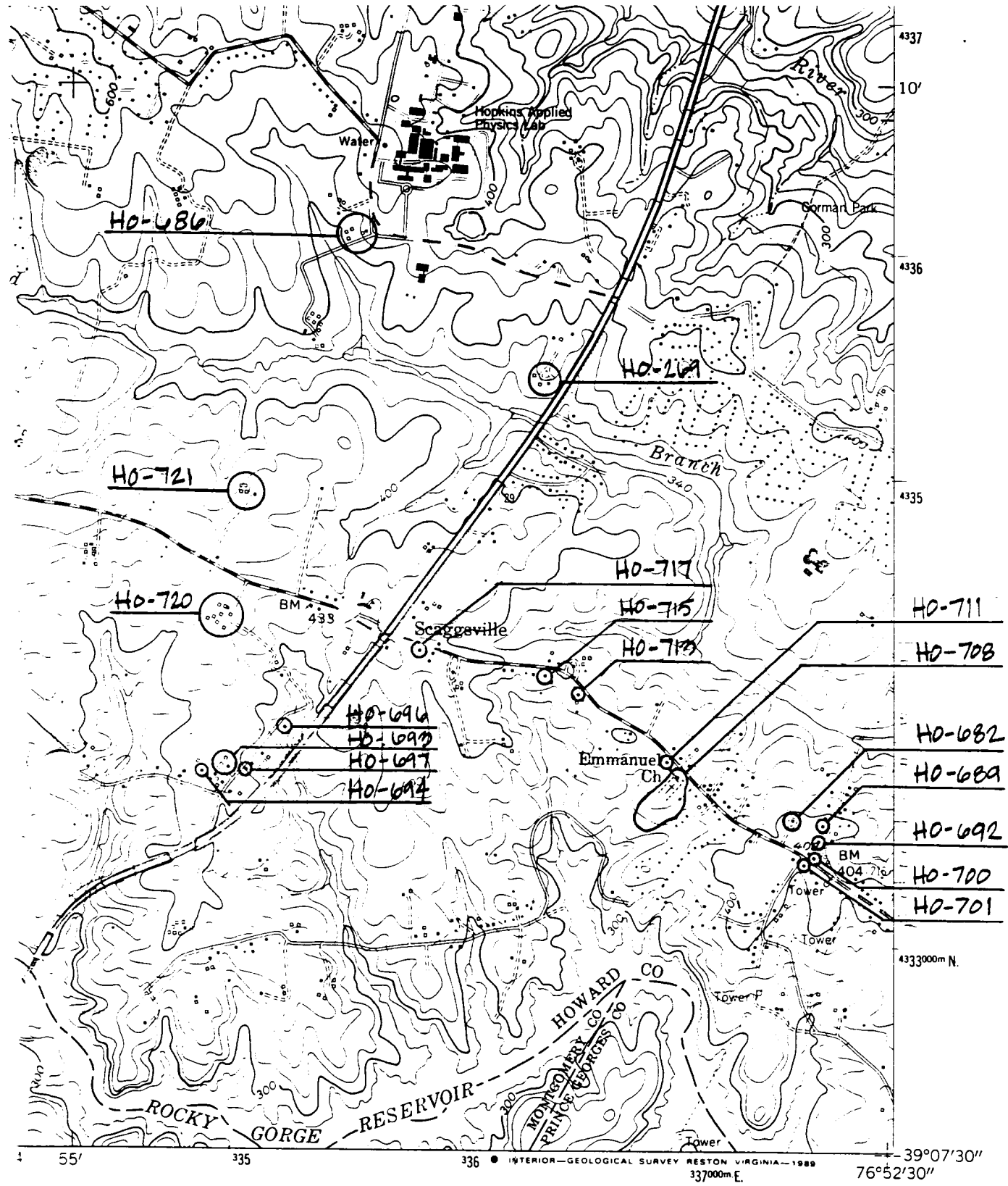
