Small Structure 13081XO over a tributary of Cattail Creek in Howard County, MD. is a concrete box culvert built ca 1931. The culvert follows the 1931 Standard Plans and includes a solid parapet wall with an incised rectangular panel and wingwalls. According to the *Small Structures on Maryland's Roadways* Historic Context Report (June 1997), concrete box culverts are common small structures and have been constructed throughout the state since 1900. They are not considered individually eligible for the National Register of Historic Places, but may be considered contributing resources to a district.

Small Structure 13081XO is not individually eligible, nor is it part of a district.

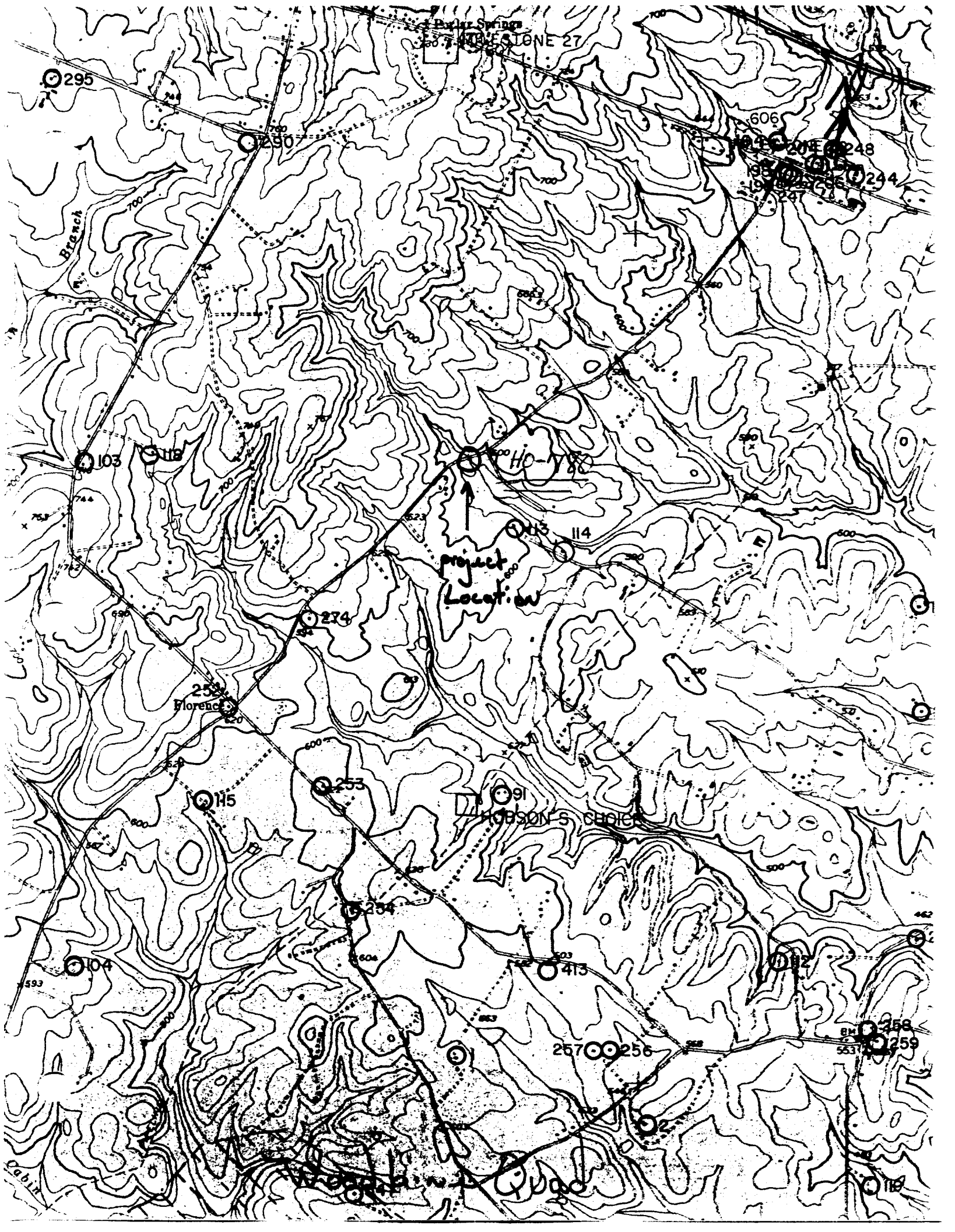
