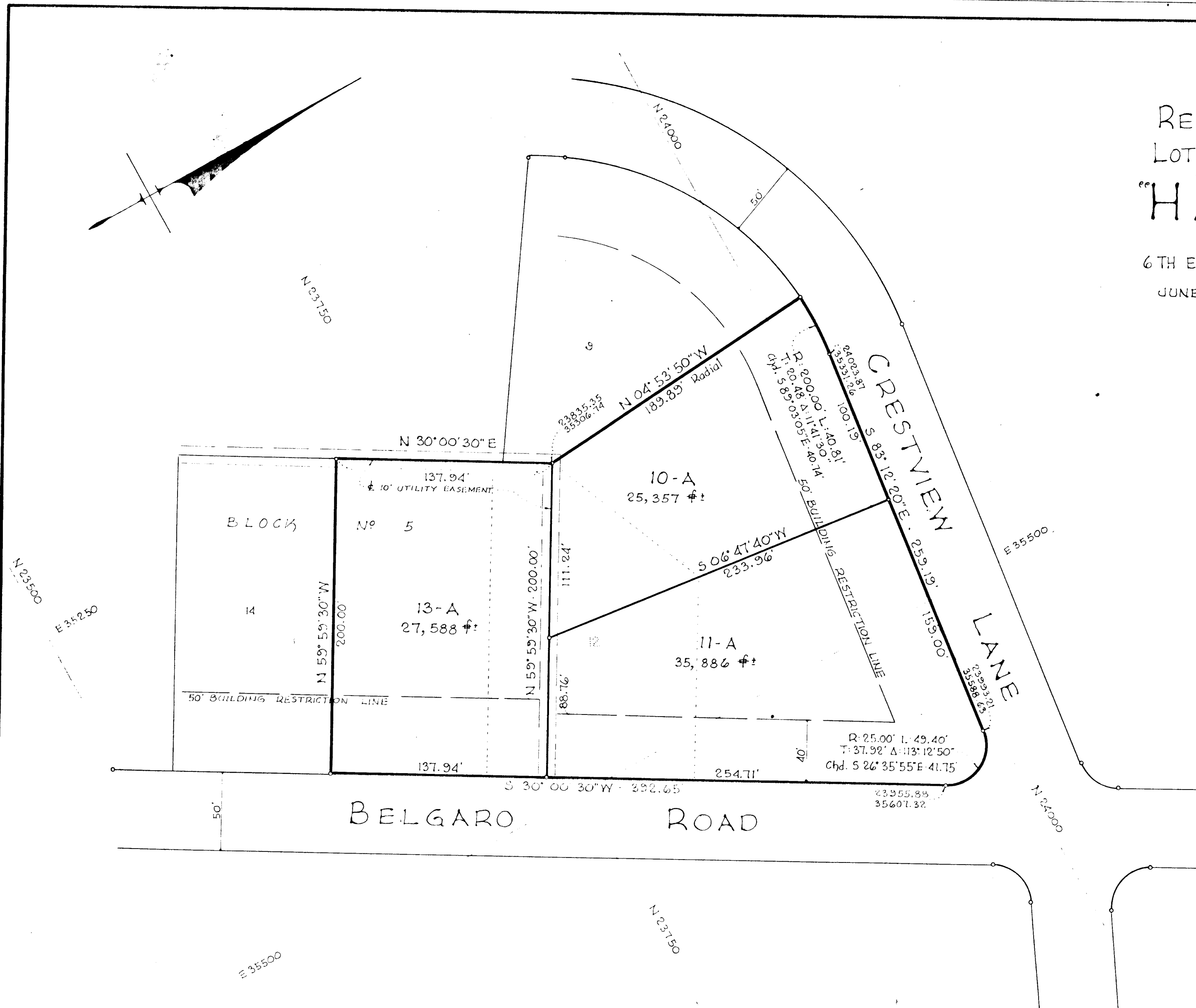


RESUBDIVISION OF LOT NO. 10 · LOT NO. 11 ·
