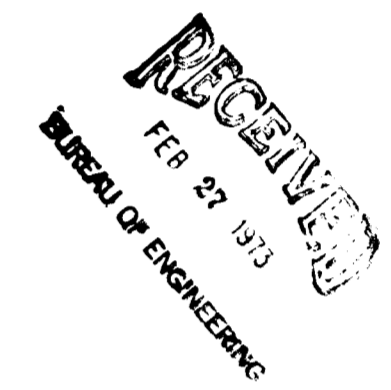
**ENGINEER'S CERTIFICATE**

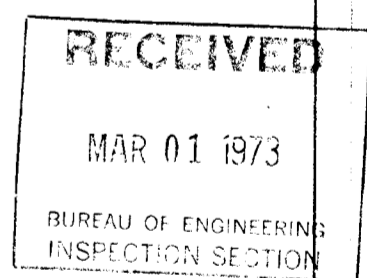
SUBDIVISION PLAT
