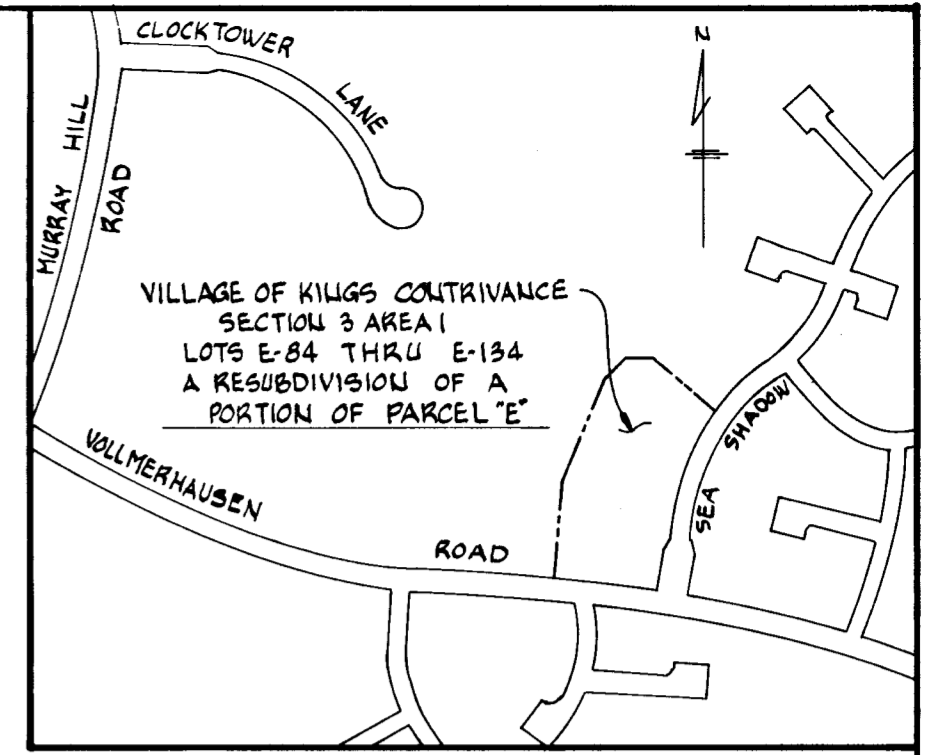


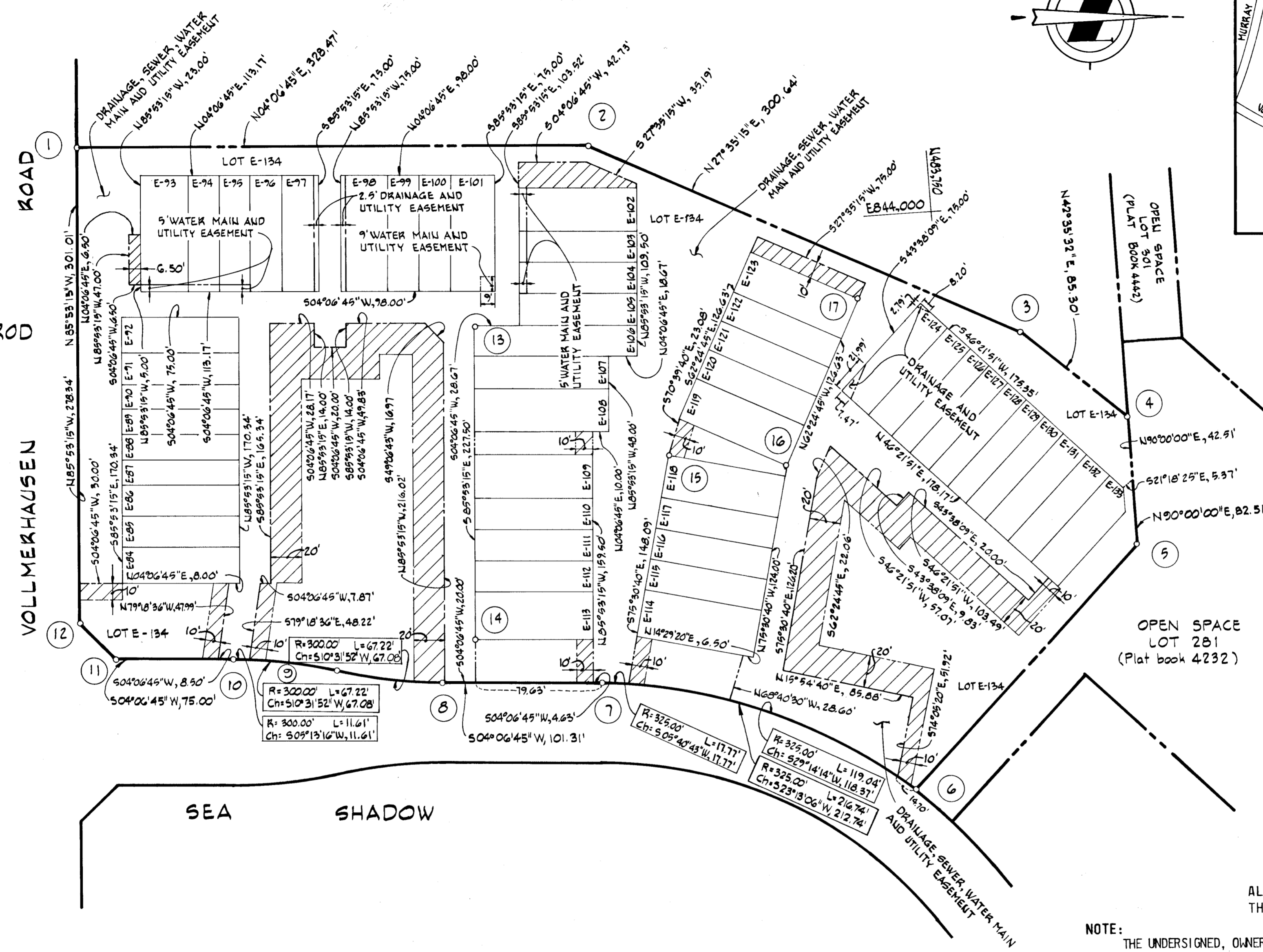
A PORTION OF PARCEL "E"
