

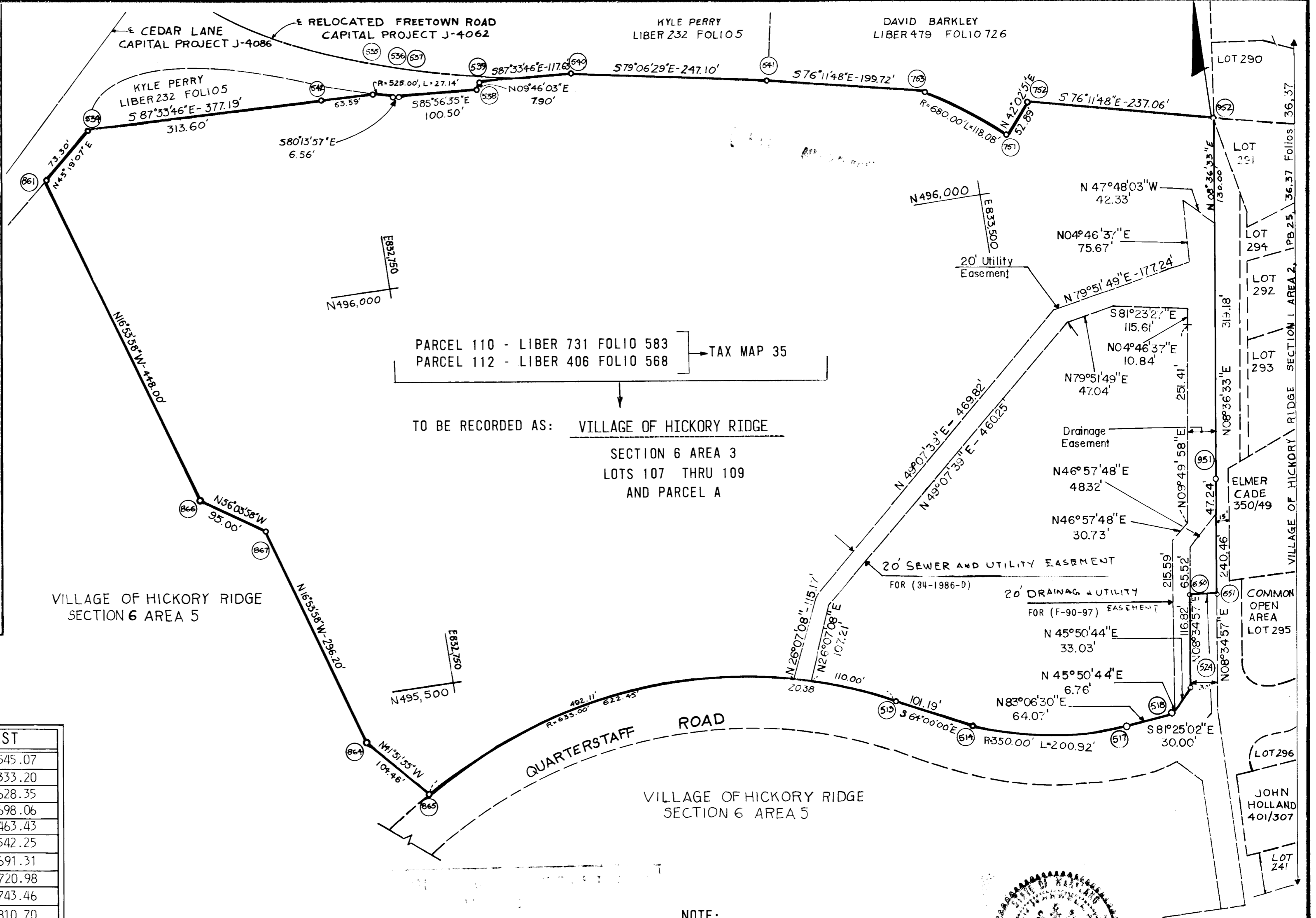
VICINITY MAP

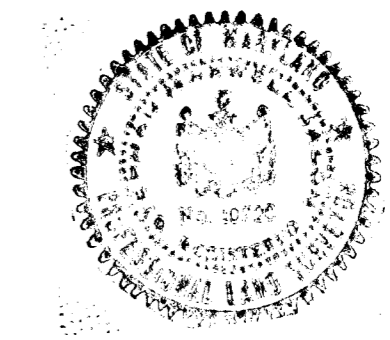
