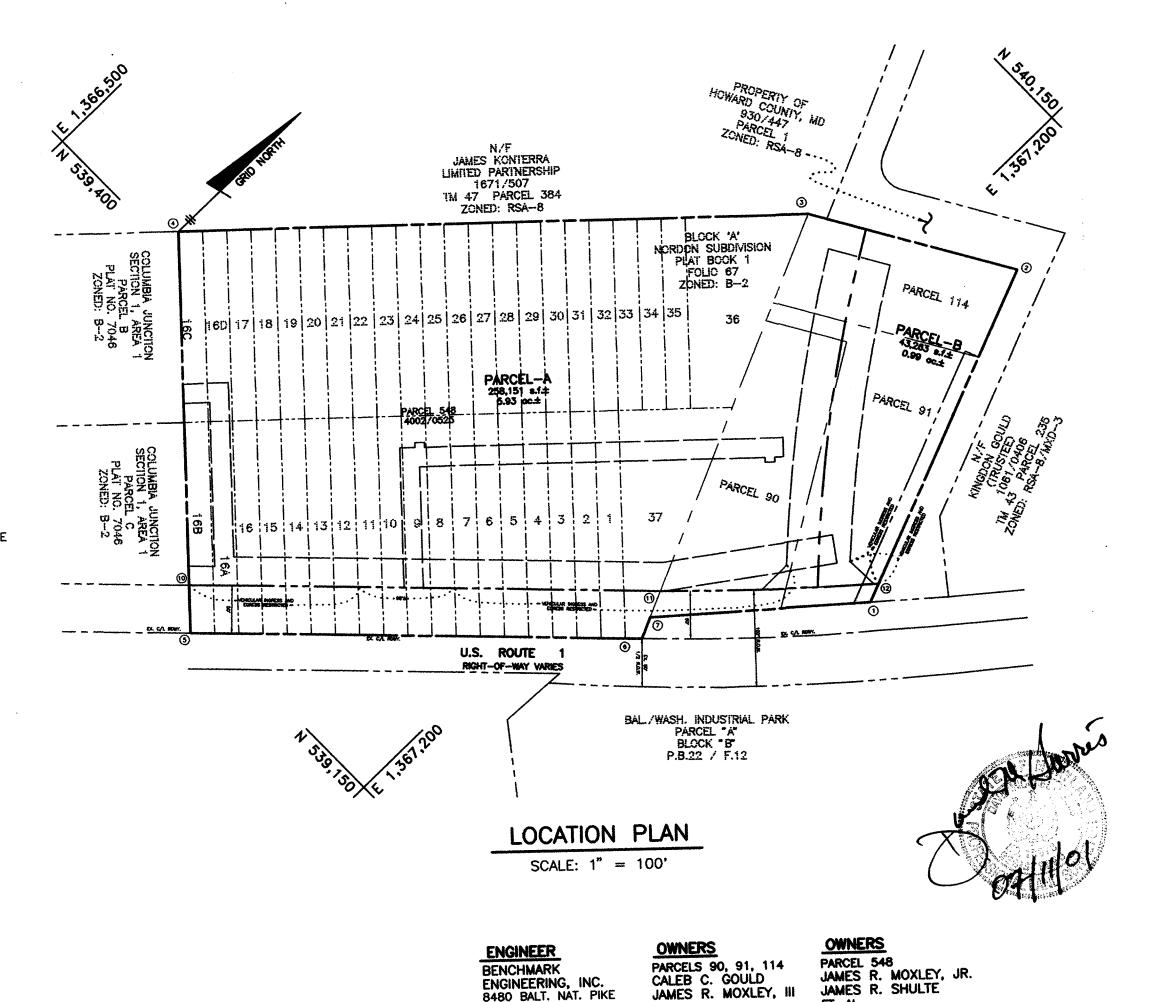

THE DEVELOPER RESERVES UNTO ITSELF, ITS SUCCESSORS AND ASSIGNS, ALL EASEMENTS SHOWN ON THIS PLAT FOR WATER, SEWER, STORM DRAINAGE AND OTHER PUBLIC UTILITIES SHOWN ON THIS PLAT FOR WATER, SEWER, STORM DRAINAGE AND OTHER PUBLIC UTILITIES LOCATED IN, ON, OVER AND THROUGH PARCELS 'A' AND 'B'. ANY AND ALL CONVEYANCES OF THE AFORESAID PARCELS SHALL BE SUBJECT TO THE EASEMENTS HEREIN RESERVED, WHETHER OR NOT EXPRESSLY STATED IN THE DEED(S) CONVEYING SAID PARCEL(S). DEVELOPER SHALL EXECUTE AND DELIVER THE DEEDS FOR THE EASEMENTS HEREIN RESERVED TO HOWARD COUNTY. UPON COMPLETION OF THE PUBLIC UTILITIES AND THEIR ACCEPTANCE BY HOWARD COUNTY, THE COUNTY SHALL ACCEPT THE EASEMENTS AND RECORD THE DEED(S) OF EASEMENTS IN THE LAND RECORDS OF HOWARD COUNTY. THE FEE-IN-LIEU PAYMENT FOR THE ENTIRE FOREST CONSERVATION OBLIGATION SHALL BE PAID WITH THE FIRST SDP SUBMITTED FOR THE DEVELOPMENT OF PARCEL "A" AND/OR PARCEL "B"
- 14. STORMWATER MANAGEMENT FOR PARCEL 'B' SHALL BE PROVIDED IN ACCORDANCE WITH THE CURRENT HOWARD COUNTY DESIGN MANUAL. STORMWATER MANAGEMENT FOR PARCEL 'A' WAS PREVIOUSLY PROVIDED WITHIN THE SWMF CONSTRUCTED AS PART OF F-88-160.
- 15. WP-99-35 WAS CONSIDERED AND DENIED ON 12/3/98, WHICH REQUESTED A WAIVER OF SECTION 16.144(a) AND (f) TO REQUIRE SUBMISSION OF A SKETCH PLAN AND PRELIMINARY PLAN FOR THE PROPOSED SUBDIVISION OF PARCELS 90, 91 AND 114.
- 16. THE 66' PRIVATE INGRESS AND EGRESS EASEMENT FOR PARCELS "A" & "B" IS INTENDED TO BECOME A PUBLIC ROAD W/66' R/W. IN THE FUTURE. AN AGREEMENT WILL BE RECORDED AMONG THE LAND RECORDS OF HOWARD COUNTY, MD CONCURRENTLY WITH THIS PLAT TO ENSURE THAT BOTH THE OWNERS OF PARCELS 'A' & 'B' WILL ALLOW FOR THE FUTURE ROAD R/W DEDICATION.
- 17. TRAFFIC STUDY WAS PREPARED BY LEE CUNNINGHAM AND ASSOC., INC. IN APRIL, 1999 AND APPROVED IN NOVEMBER, 1999.

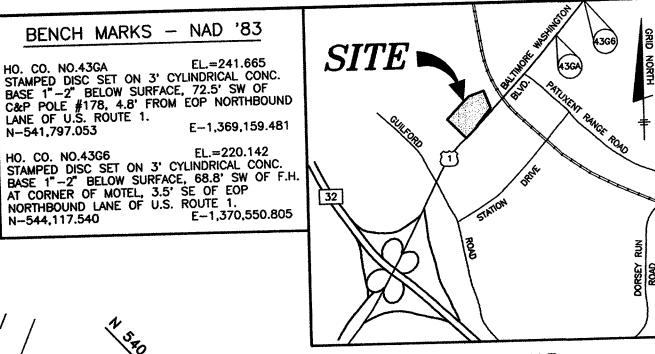
