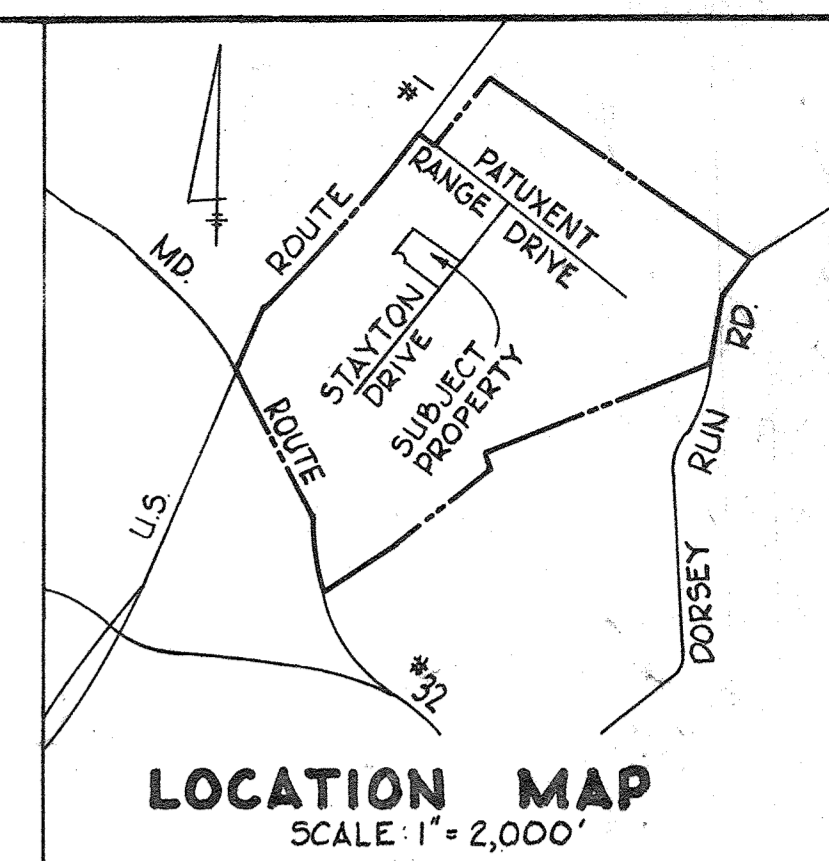
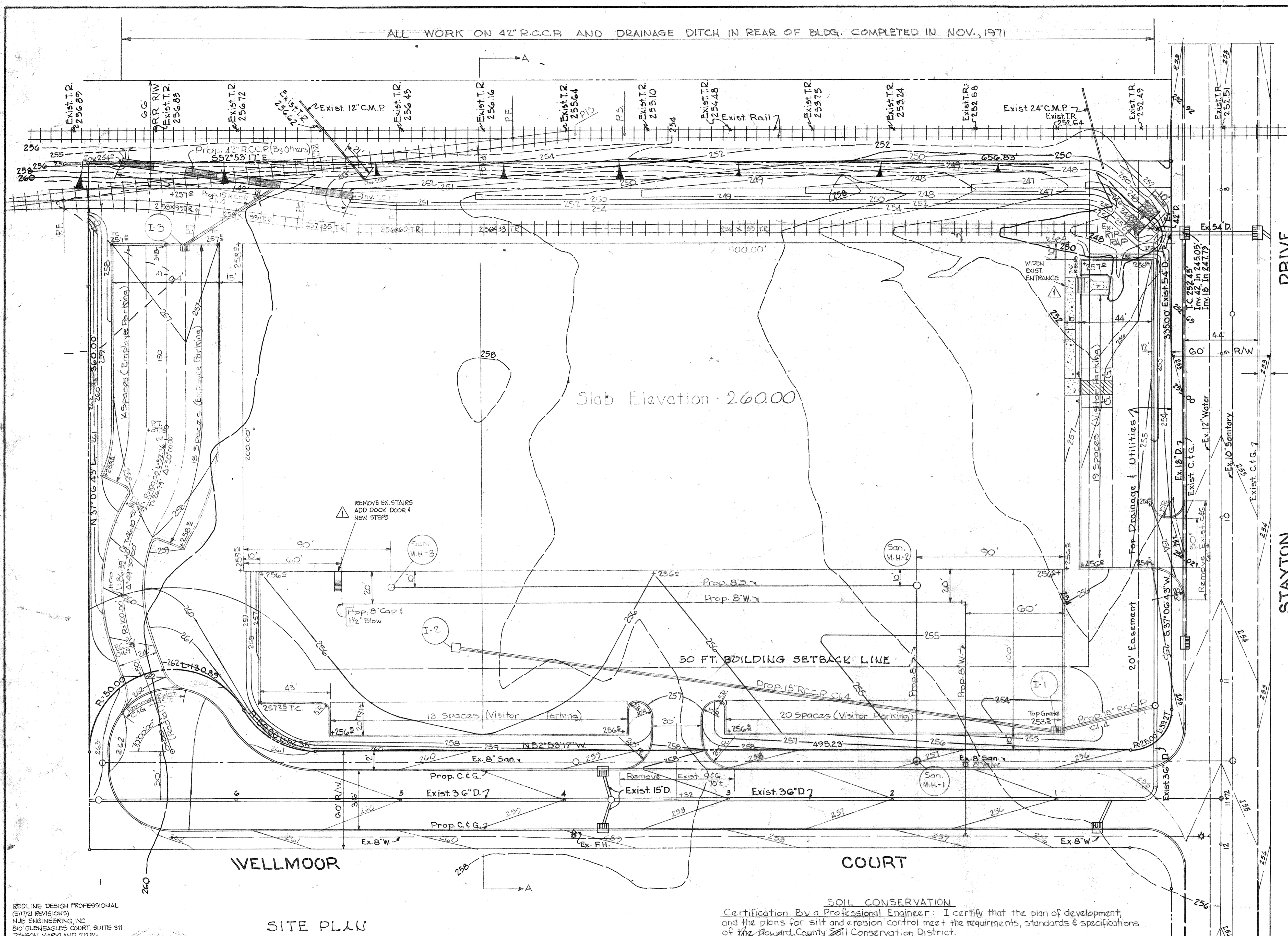


ALL WORK ON 42" R.C.C.P. AND DRAINAGE DITCH IN REAR OF BLDG. COMPLETED IN NOV., 1971
