




SEDIMENT CONTROL NOTES .

1. SPECIFICATIONS FOR THE SEDIMENT CONTROL DETAILS INCLUDED IN THE U.S.D.A. SOIL CONSERVATION SER-VICE "STANDARDS AND SPECIFICATIONS FOR SOIL EROSION AND SEDIMENT CONTROL IN DEVELOPING

2. THE DEVELOPER SHALL NOTIFY THE HOWARD COUNTY OFFICE OF INSPECTION AND PERMITS AT LEAST 24 HOURS PRIOR TO BEGINNING ANY CONSTRUCTION SHOWN HEREON(792-7272)

3. SEDIMENT CONTROL STRUCTURES TO BE CONSTRUCTED PRIOR TO ANY ON-SITE GRADING OR DISTURBANCE TO ANY EXISTING SURFACE MATERIAL, AND ARE TO BE STABILIZED AS SOON AS CONSTRUCTED. 4. ALL SEDIMENT CONTROL STRUCTURES TO REMAIN IN

PLACE UNTIL PERMISSION FOR THEIR REMOVAL HAS BEEN OBTAINED FROM THE HOWARD COUNTY OFFICE OF INSPECTION AND PERMITS(792-7272) 5. ALL GRADED AREAS NOT TO BE SODDED SHALL BE STABILIZED BY SEEDING AND MULCHING IN ACCORD-

1. SITE PREPARATION

ANCE WITH THE FOLLOWING:

A. HARROW OR DISC IN AREAS PROPOSED TO BE SEEDED THE FOLLOWING MATERIALS 1) PULVERIZED LIMESTONE AT 2 TONS/ACRE 2) COMMERICAL FERTILIZER 10-10-10 AT 3/4 TONS/ACRE.

3) SUPER PHOSPHATE AT 600 LBS./ ACRE.

2. SEEDING

A. SOW THE FOLLOWING SEED MIXTURE AT THE RATE OF 200 LBS./ACRE WITH A MECHANICAL SPREADER.

1) TEMPORARY: ITALIAN OR PERENNIAL RYE 2) PERMANENT: 40% MARION BLUE GRASS, 40% DAKOTA BLUE GRASS AND 20% PENN LAWN

CREEPING FESCUE. B. THE SEEDED AREA SHALL THEN BE RAKED WITH A YORK RAKE (A MINIMUM OF 2 PASSES) COVERED AND COMPACTED WITH CULTIPACKER OR OTHER APPROVED METHOD.

3..MULCHING

A. SEEDED AREAS SHALL BE UNIFORMLY MULCHED IMMEDIATELY AFTER SEEDING WITH UNWEATHERED SMALL GRAIN STRAW AT THE RATE OF 1 1/2-2 TONS/ACRE. B. TIE MULCH DOWN WITH LIQUID ASPHALT AT 0.1

GAL./S.Y. OR EMULSIFIED ASPHALT AT 0.04 GAL./S.Y. OR MULCH NETTING.

CONSTRUCTION SEQUENCE

1. OBTAIN GRADING PERMIT.

2. INSTALL STABILIZED CONSTRUCTION ENTRANCE. INSTALL STRAW BALE DIKE OR SILT FENCE. 3. CONSTRUCT MINI-HUT AND INSTALL SPLICE CABINET.

4. FINE GRADE SITE AND STABILIZE WITH SEED & MULCH. INSTALL

LANDSCAPE MATERIALS AND SPLIT RAIL FENCE.

5. REMOVE STRAW BALE DIKE OR SILT FENCE AND STABILIZE ANY REMAINING DISTURBED AREAS WITH SEED & MULCH.

6. REMOVE STABILIZED CONSTRUCTION ENTRANCE AND STABILIZE WITH
