


SEQUENCE OF CONSTRUCTION:

1. OBTAIN GRADING PERMIT
2. NOTIFY HOWARD COUNTY OFFICE OF INSPECTION AND PERMITS 24 HOURS PRIOR TO STARTING WORK
3. INSTALL ALL SEDIMENT CONTROL FEATURES
4. ROUGH GRADE SITE
5. FINE GRADE SITE
6. STABILIZE SITE PER PERMANENT SEEDING PROCEDURES
7. REMOVE SEDIMENT CONTROL DEVICES AND STABILIZE THOSE AREAS AFTER APPROVAL BY HO. CO. SEDIMENT CONTROL INSPECTOR.
