The purpose of this letter is to inform you that we are unable to process your request for reconsideration of Waiver Petition WP-16-097 denial of Section 16.116(a) for the single driveway crossing for Preservation Parcel A because the request was not submitted within the 30-day reconsideration period as required by Section 16.104(b) (3) of the Subdivision and Land Development Regulations.
