Brief Summary of Request: The project being proposed is a capital project, which needs to be done as soon as possible due to the severity of corrosion in the pond principal spillway pipes and the amount of erosion forming on the stormwater management embankment. Addressing these deficiencies will cease damage to adjacent improved roadways and to prevent continued degradation of critical functions of the stormwater pond. We propose to the capital improvement design plans to serve in place of a formal site development plan.

Brief Summary of Request: The sum of the area of the three lots is 7.98 acres; however, the proposed limit of disturbance (LOD) is only 2.12 acres. We propose to use the LOD in place of the net tract area for forest conservation computations as only a small portion of County-owned lands will be physically impacted by stabilization construction.
