

GENERAL NOTES

- 1. Approximate location of existing mains are shown. The contractor shall take all necessary precautions to protect existing mains and services and maintain uninterrupted supply. Any damage incurred shall be repaired Immediately to the satisfaction of the Engineer at the Contractor's
- 2. All horizontal controls are based on Maryland State Coordinates.
- 3. All vertical controls are based on U.S.G.S. data,
- 4. All pipe elevations shown are invert elevations.
- 5. Clear all utilities by a minimum of 6". Clear all poles by 2'-0" minimum or tunnel as required. The owner has contacted the utility companies and has made arrangements for bracing of poles as shown on the drawings. In the event the contractor's work requires the bracing of additional poles, any cost incurred by the owner for bracing of additional poles or damages shall be deducted from money owed the contractor. The contractor shall coordinate with the utility companies to schedule the bracing of the poles.
- 6. For details not shown on the drawings, and for materials and construction methods use Howard County Design Manual, Volume IV, Standard Specifications and Detail for Construction. (Latest Edition). The contractor shall have a copy of Volume IV on the job.
- 7. Where test pits have been made on existing utilities, they are noted by the at the location of the test pit. A note or notes containing the results of the test pit or pits is included on the drawings. Existing utilities in the vicinity of the proposed work for which test pits have not been dug shall be located by the contractor two weeks in advance of construction operations at his own expense.
- 8. Contractor shall notly the following utility companies or agencies at least five working days before starting work shown on these plans:

State Highway Administration Baltimore Gas & Electric Co. Contractor Services Baltimore Gas & Electric Co. Underground Damage Control Miss Utility Colonial Pipeline Co.

Bureau of Utilities, Howard County Department of Public Works 9. Trees and shrubs are to be protected from damage to maximum extent. Trees

- and shrubs located within the construction strip are not to be removed or damaged by the contractor.
- 10. Contractor shall remove trees, stumps and roots along line of excavation. Payment for such removal shall be included in the unit price bid for construction of the main.
- 11. All water mains to be D.I.P. Class 52 unless otherwise noted.
- 12. Tops of all water mains to have a minimum of 3-1/2' cover unless otherwise
- 13. Valves adjacent to tees shall be strapped to tees.
- 14. All fittings shall be buttressed or anchored with concrete in accordance with the Standard Details unless otherwise provided for on the drawings.
- 15. Fire hydrants shall be set to the bury line elevations shown on the drawings. All fire hydrants shall be restrained and buttressed with concrete in accordance with Standard Details. Soil around the fire hydrant shall be compacted in accordance with Section 1000 and 1005 of the Standard Specifications. Fire hydrants shall be installed as per standard detail W.l.ll.
- 16. The contractor shall not operate any water main valves on the existing
- 17. All water house connections shall be for inside meter setting unless otherwise noted on plans or in specifications.
- 18. All sewer mains shall be DIP and P.V.C. unless atherwise noted.
- 19. All manholes shall be 4'-0" inside diameter unless otherwise noted.
- 20. Force mains shall be D.I.P. only. 21. Manholes shown with 12" and 16" walls are for brick manholes only.
- Manholes designated W.T. In plan and profile shall have watertight frame and covers, Standard Detail G5.52. Where watertight manhole frame and cover is used, set top of frame 1"-6" above finished grade unless otherwise noted on the drawings.
- 23. House(s) with the symbol "C.N.S." Indicates that cellar cannot be served.
- 24. Manholes can be either brick or precast concrete structures.
- 25. Contractor is solely responsible for construction means, methods, techniques,
- sequences, procedures, and safety precautions and programs. 26. Fire hydrants will be located 3' FROM BACK OF CURB unless otherwise noted.
- A. AREA THROUGH EWINF # I EMBANKMENT TO BE CONSTRUCTED ALONG WITH EMBANKMENT LIFTS (DO NOT RETRENCH POND FILL).
- B. COMPACTED EARTH TO BE USED ONLY (NO GRAVEL BEDDING).
- C. LISE RESTRAINING JOINTS FROM WATER MAIN STA. 0+50 TO STA. 5+50.
