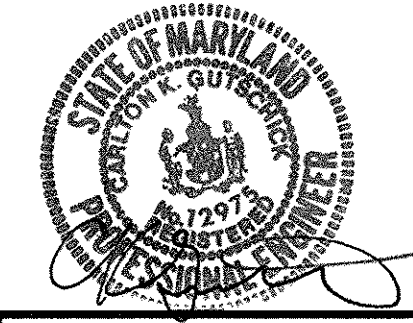
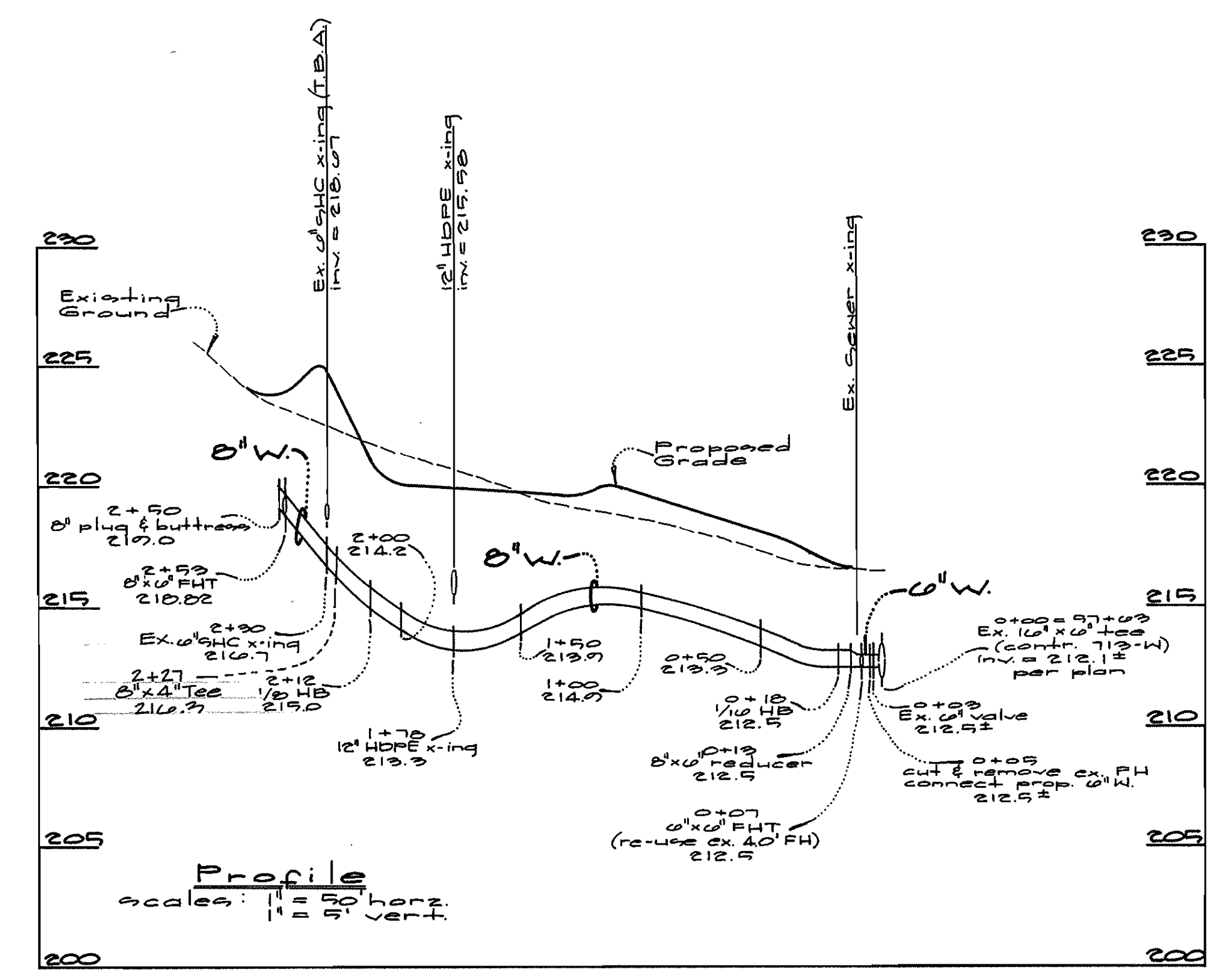


PLAN VIEW

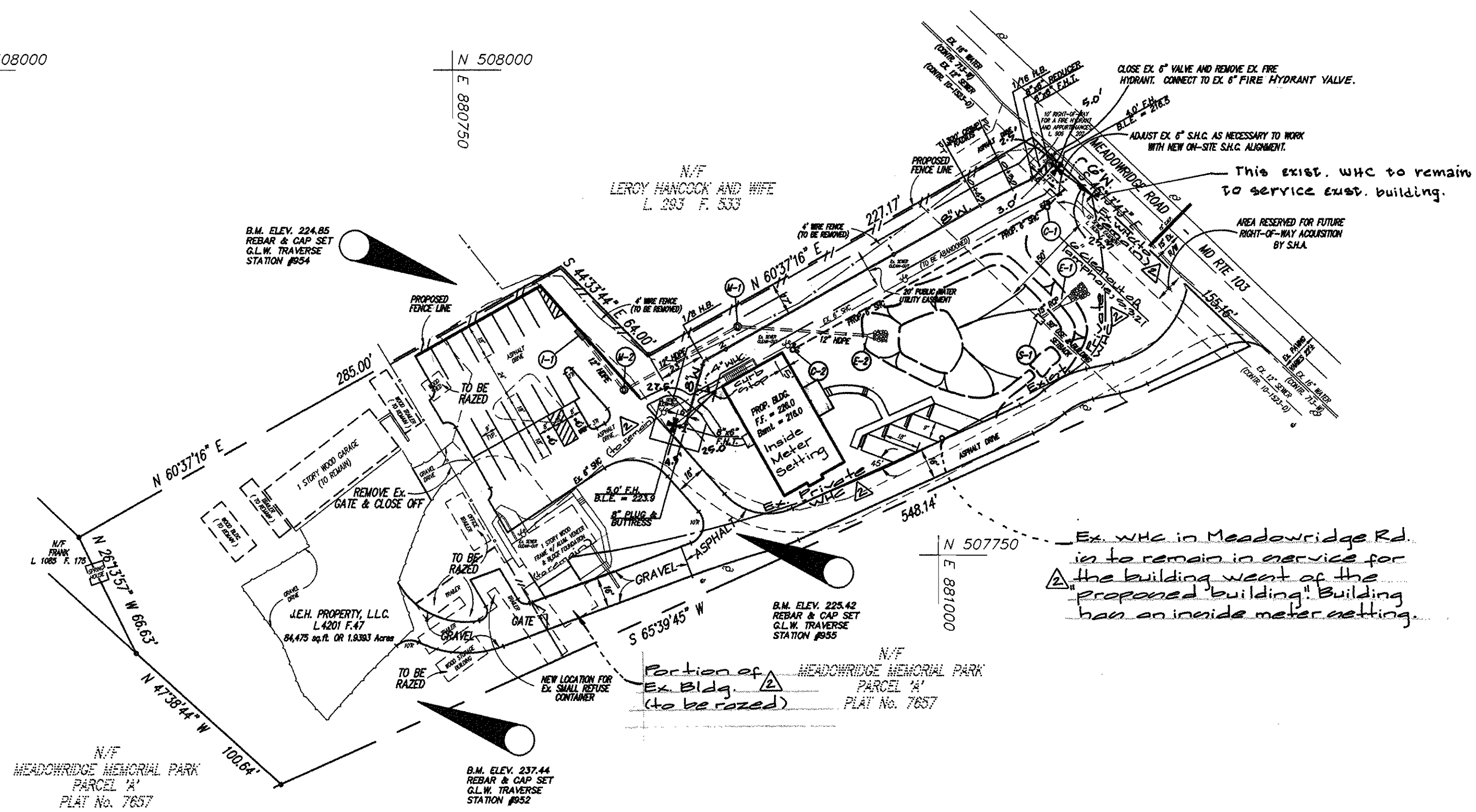

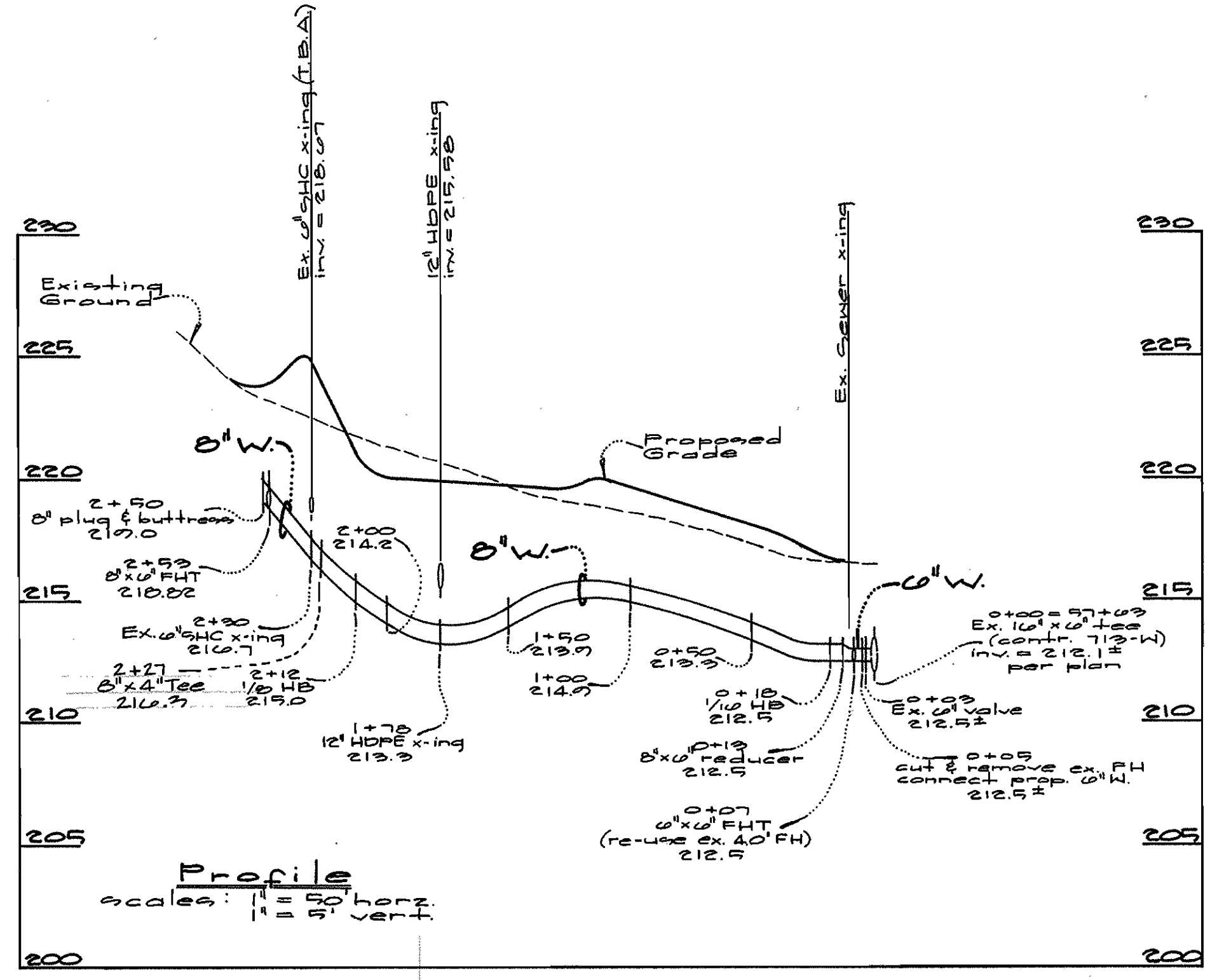
